Sub: - Revision of MES Group 'C' & 'D' Staff's Pension as per 7th CPC.

Most Respected Sir,

Revision of pension of Central Govt. Civilian Staff is approved by Govt. of India and Govt. had issued directions for revision on priority in July 2017. Large numbers of revision cases are required to be taken up by Command Record Offices to PCDA Allahabad.

On going through the progress of disposal of pending cases, it appears that speed of processing at command level is not adequate and cases sent to PCDA Allahabad are very less.

The digitalization of Record Offices at command HQ level may also be taken up as is being done at CRO Delhi Cantt (in case of Group 'A' & 'B' officers) to enable trouble free monitoring by Higher HQ and grievances redressal be computerized for the benefit of retired MES staff.

It is requested that all commands may please be directed to take up the matter in time and bound manner so that pensioners may get their dues in reasonable time and may lodge their grievance on internet.
