का०नि०आ० 107.—राष्ट्रपति, संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए सैनिक इंजीनियरी सेवा, रक्षा मंत्रालय में ज्येष्ठ निजी सचिव पद पर भर्ती की पद्धति का विनियमन करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात् :—

- 1. संक्षिप्त नाम और प्रारंभ.—(1) इन नियमों का संक्षिप्त नाम 'सैनिक इंजीनियरी सेवा, (ज्येष्ठ निजी सचिव) भर्ती नियम, 2003 है।

- 2. **पद संख्या, वर्गीकरण और वेतनमान.** उक्त पद की संख्या, उसका वर्गीकरण और उसका वेतनमान वह होगा, जो इन नियमों से उपाबद्ध अनुसूची के स्तम्भ 2 से स्तम्भ 4 में विनिर्दिष्ट हैं।
- 3. भर्ती की पद्धित, आयु-सीमा और अन्य अर्हताएं आदि.— उक्त पद पर भर्ती की पद्धित, आयु-सीमा और उससे सम्बन्धित अन्य बातें वे होंगी जो पूर्वोक्त अनुसूची के स्तम्भ 5 से स्तम्भ 14 में विनिर्दिष्ट हैं।

- 6. व्यावृत्ति.—इन नियमों की कोई बात ऐसे आरक्षणों, आयु-सीमा में छूट और अन्य रियायतों पर प्रभाव नहीं डालेगी, जिनका केन्द्रीय सरकार द्वारा इस संबंध में समय-समय पर निकाले गए आदेशों के अनुसार अनुसूचित जातियों, अनुसूचित जनजातियों, अन्य पिछड़े वर्गों, भूतपूर्व सैनिकों और अन्य विशेष प्रवर्ग के व्यक्तियों के लिए उपबंध करना अपेक्षित है।

- S.R.O. 107.— In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules regulating the method of recruitment to the post of Senior Private Secretary in Military Engineer Services, Ministry of Defence, namely:—
- 1. Short title and commencement.—(1) These rules may be called the Military Engineer Services (Senior Private Secretary) Recruitment Rules, 2003.
  - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of posts, classifications and scales of pay.—The number of the said posts, its classifications and scales of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.
- 3. Method of recruitment, age limit and other qualifications, etc..—The method of recruitment, age limit and other matters relating to the said post shall be as specified in columns 5 to 14 of the aforesaid Schedule.
  - 4. Disqualifications.— No person,—
    - (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedients so to do, it may by order and for reasons to be recorded in writing and in consultation with UPSC, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving.—Nothing in this rule shall affect reservations, relaxation of age limit and other concessions required to be provided for Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, Ex-servicemen and other special categories of persons, in accordance with the orders issued by the Central Government from time to time in this regard.
