- In case number of eligible class contractors satisfying the eligibility criteria given in NIT are 7 or morethan 7, applications of one class below the eligible class shall not be considered except those who have previously completed similar works satisfactorily and are meeting the criteria of up gradation in respect of past experience and/or average annual turnover as applicable and financial soundness (solvency/financial soundness and working capital) provided the value of works is less than twice the tendering limit of such contractors. wrt works experience and financial soundness in cover-1 of tender (T bid).
