Annual turnover certificate for last 2 years issued by Charted Accountant alongwith (iii) relevant pages of audited balance sheets in support thereof.

Affidavits for possession of movable & immovable properties by proprietor/partner (iv) owning the immovable property along with valuation certificate from Regdvaluer in support of movable & immovable properties. In case of Limited Company the immovable property is required to be in the name of company.

In addition, the un-enlisted contractors shall also furnish affidavit on non –Judicial stamp (v) paper in the form of hard copy declaring their turnover for last 2(Two) years.

Scanned copy of DD of cost of tender and earnest money. (vi)
