### 4. LIMIT OF MINIMUM RESERVE/ASSETS (IMMOVABLE AND MOVABLE)

12.50 lakhs - 80% of minimum reserve shall be in the form of immovable property.

5. T&P -The firm should give an affidavit duly notarized for the T&P held by them.

#### 6. POLICE VERIFICATION

Copy of police verification certificate from police authority of the area where registered office is located.

Alternatively notarized copy of valid passport of proprietor/ each partner/ each director can be submitted.

# 7. CERTIFICATE REGARDING NO RECOVERY OUTSTANDING IN ANY GOVT DEPARTMENT

Affidavit duly notarized to this effect to be furnished.

8. List of works alongwith performance report from the department in support of experience of similar nature of work.
