(i) The applicant contractor shall note that the Demand Draft/Banker's cheque shall be in favour of **GE (U-II) Visakhapatnam payable at Visakhapatnam.** Cost of tender documents shall be non-refundable in the event of opening of cover No 2 (Price Bid). However DD/ Banker's Cheque shall be returned to the applicants whose cover No. 2 is not opened. The applicant/contractor, if he so desires, may appeal to the Next Higher Engineer Authority i.e. HQ Commander Works Engineers, Visakhapatnam with copy to the Accepting Officer up-to seven days prior to the date of opening of Price Bid (Cover No. 2) or as otherwise informed


Note No 2:-
