  - (ii) Tenderers/ bidders to note that they should ensure that their original DDs and earnest money (as applicable) are received within 08 days of bid submission end date.

Name of such contractors along with complete address shall be circulated for not opening of their bids for a period of six months commencing from the date of opening of finance bid.
  - (v) In case of applications/bids (enlisted contractor as well as un-enlisted contractor) where scanned copies of requisite Earnest money (as applicable) were uploaded but the same are not received in physical form within stipulated time, such bids shall not qualify for opening of finance bid.

- (d) Contractors not enlisted with MES will be required to upload necessary documents to prove their eligibility for enlistment in eligible class & category of work, including Affidavit for no recovery outstanding. List of documents required for enlistment in MES has been given in Para 1.5 of Section 1 of Part -I of MES Manual of Contracts 2007 (Reprint 2012). Following documents shall also be uploaded amongst others:-
  - (i) Details of three highest valued similar nature of works executed during last five years, financial year-wise in tabular form giving name of work, Accepting Officer's details viz., Address, Telephone No., Fax No., e-mail ID etc., date of acceptance of tender and actual date of completion. This shall be duly signed by proprietor/all partners/authorised Director of Pvt/Public Ltd, as applicable. It should indicate whether extension was granted or compensation was levied. Attested copy of acceptance letter and completion certificate shall be enclosed of each work. In case performance report has been given by the client same shall also be submitted duly attested.
  - (ii) Solvency certificate and working Capital Certificate issued by scheduled bank.
  - (iii) Annual turnover certificate for last 2 years issued by Chartered Accountant along with relevant pages of audited balance sheets in support thereof.
  - (iv) Affidavits for possession of movable & immovable properties by proprietor/ partner owning the immovable property along with Valuation Certificate from Regd Valuer in support of movable & immovable properties. In case of Limited Company, the immovable property is required to be in the name of the company.

- (v) In addition, the un-enlisted contractors shall also furnish affidavit on non Judicial stamp paper in the form of hard copy declaring their turnover for last 02 (Two) years.
- (vi) Scanned copy of DD towards cost of tender and earnest money.
- (v) Scanned copy of permanent allotted EPFO number (OR) Copy of proof of application for EPF number (Temporary).
- (vi) Scanned copy of GST Registration Number..
- (e) In case of rejection of technical/prequalification bid, contractor may appeal to next higher Engineer authority viz., **Chief Engineer (AF) Bengaluru.** on e-mail id **cezafb2-mes@nic.in** against rejection, whose decision shall be final and binding.
