The Performance Security shall be valid till expiry of Defects Liability Period as stipulated here-in-after PLUS Two Months. In case the Bidder / Service Provider fails to deposit the Performance Security within the stipulated period, the award of work shall be cancelled and Earnest Money deposited by him shall be forfeited. In case of MES enlisted Bidders / Service Providers, the amount equal to the Earnest Money stipulated hereinabove, shall be notified to the Bidder / Service Provider for depositing the amount through MRO. Issue of GeM Order to such Bidder / Service Provider shall remain suspended till the aforesaid amount equal to Earnest Money is deposited in Government Treasury. The Bidder / Service Provider shall not be entitled for any compensation whatsoever on this account. The Work Order for commencing the work shall be placed after receipt of above Performance Security within the stipulated time period.

2. **APPLICABLE TO DGNP ENLISTED CONTRACTORS ONLY** : The tenderers who are enlisted with DGNP Visakhapatnam / Mumbai shall submit earnest money deposit (EMD) for the amount as indicated above.
