#### NOTES

1. The contractor enlisted upto - class below the eligible class may also upload bid. Bids from - class below eligible class may be considered in the event of inadequate response from eligible class.

- 2. (a) Application /bids not accompanied by scanned copies of requisite DD / Bankers Cheque towards cost of tender and earnest money (as applicable) shall not be considered for validation of "T" bid and their finance bids will not be opened.
  - (b) Tenderers/bidders to note that they should ensure that their original DDs and earnest money (as applicable) are received within 05 (FIVE) days of bid submission end date.
  - (c) In case of application/bids from enlisted contractor of MES, where scanned copies of requisite DD/Bankers Cheque towards cost of tender has been uploaded but physical copies are not received by the stipulated date, finance bids will be opened. However, non-submission of physical copies of cost of tender shall be considered as willful negligence of the bidder with ulterior motives and such bidder shall be banned from bidding for a period of six months commencing from the date of opening finance bid.
  - (d) In case of application /bids from unenlisted contractors where scanned copies of requisite DD/Bankers cheque towards cost of tender has been uploaded but physical copies are not received by the stipulated date, finance bid will not be opened. Name of such contractors alongwith complete address shall be circulated for not opening of their bids for a period of six months commencing from the date of opening of finance bid.
