(iii) In case of applications / bidders from enlisted contractors of MES, where scanned copies of requisite DD / Bankers cheque towards cost of tender has been uploaded but physical copies are not received by the stipulated date, finance bids will be opened. However non-submission of physical copies of cost of tender shall be considered as willful negligence of the bidder with ulterior motives and such bidder shall be banned from bidding for a period of six months commencing from the date of opening of finance bid.

(iv) In case of application/bids from enlisted contractors where scanned copies of requisite DD/Bankers cheque towards cost of tender has been uploaded but physical copies are not received by the stipulated date finance bids will not be opened. Name of such contractors alongwith complete address shall be circulated for not opening of their bids for a period of six months commencing from the date of opening of finance bid.

(v) In case of application/bids (enlisted contractor as well un-enlisted contractor) where scanned copies of requisite Earnest money (as applicable ) were uploaded but the same are not received in physical form within stipulated time, such bids shall not qualify for opening of finance bid.

(c) Contractor unlisted with MES will upload following documents for checking eligibility:-

- (i) Application for bid in Firm's letter head.
- (ii) Enlistment letter alongwith details.
- (iii) Scanned copy of DD for cost of tender.
- (iv) Scanned copy of EPF Number.
- (v) Scanned copy of GST Registration Number.

(d) Contractor not enlisted with MES will be required to upload necessary documents to prove their eligibility for enlistment in eligible class & category of work, including Affidavit for no recovery outstanding. List of documents required for enlistment in MES has been given in para 1.5 of section 1of part I of MES Manual on contracts 2007 (reprint 2012). Following documents shall also be uploaded amongst others.

(i) Details of three highest valued similar nature of works executed during last five years, financial year-wise in tabular form giving name of work. Accepting officer's details viz address, Telephone, Fax No E-mail ID etc, date of acceptance of tender and actual date of completion. This shall be duly signed by proprietor / all partners / authorised director of Pvt / Public Ltd. As applicalbe. It shold indicate whether extension was granted or compensation was levied. Attested copy of acceptance letter and completion certificate shall be enclosd of each work. In case performance report has been given by the client same shall also be submitted duly attested.

(ii) Solency certificate and working capital certificate issued by scheduled bank.

(iii) Annual turnover certificate for last 2 year issued by chartered Accountant along with relevent pages of audited balance sheets in support thereof.

(iv) Affidavit for possession of movable & immovable properties by proprito/partner owning the immovable property along with valuation certificate from Regd valuer in support of movable & immovable properties. **In case of limited company, the immoalbe property is required to be in the name of the company.**

(v) In addition the un-enlisted contractors shall also furnish affidavit on non judicial stamp paper in the form of had copy declaring their turnover for last 2 (Two ) years.

(vi) Second copy of DD of cost of tender and earnest money.

(e) In case of rejection of technical/prequalification bid, contractor may appeal to next higher Engineer authority i.e CWE (AF) Izatnagar Bareilly on email cweizne8@gmail.com against rejection, whose decision shall be final and binding. However contractor / bidder shall not be entitled to any compensation whatsoever for rejection of technical/ prequalification bid.

(f) Uploading of copy of provident fund code number in addition to other documents is mandatory. The contractor not in possession of this No. shall be disqualified in "T" bid evaluation and his finance bid shall not be opened.
