BEFORE 01 JAN 2004 BUT WHO JOINED GOVERNMENT
SERVICE ON OR AFTER 01 JAN 2004**

1. Ref Central Record Office (Officers) letter No CRO/Gen/50/Ops dt 17 Aug 2020 (copy enclosed).

2. It is mentioned that many cases pertaining to subject matter of Group 'B' (Gazetted) Officers are being received at E-in-C's Branch, either directly as advance copy or through your HQ CE Command. The same is not in order and following is elaborated for fruitful disposal of ibid cases :-

- (a) The Appointing Authority for Gp 'B' Officers is HQ CE Command.
- (b) The Gp 'B' (Gazetted) Officer has joined MES based on their appointment as Gp 'B' (Non Gazetted) which is done by respective HQ CE Command. Hence, Appointing Authority for them remains same.
- (c) Appointing Authority has to deal with the case based on the merits in terms of Para 03 of GOI, Department of Pension and PW, New Delhi OM No 57/04/2019-P&PW(B) dt 17 Feb 2020.



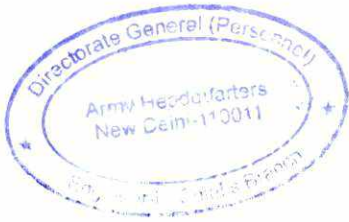

(d) After finalization of ibid cases, necessary report is to be submitted to E-in-C's Branch (E1B Cadre & CRO (O)) in case of Gp 'B' (Gazetted) Officers only for updation of officer's Records.

3. In view of the above, all the cases pertaining to your Command received in this office are returned herewith unactioned with instructions to process these cases in time bound manner as mentioned above.

4. It is important to mention here that abnormal delay in finalization of ibid cases is likely to lead to litigations and criticism from the environment. Hence, same should be avoided in all possibilities.
