2. Your request for upgradation of your firm from class 'E' to class 'D' (**upper tendering limit Rs. 50.00 lakh**) has been approved by the Registering Authority i.e. Chief Engineer Central Command Lucknow for the existing categories of works:-

- (a) **Civil Engineering Works.**
 - (i) Building Works.
 - (ii) Water supply and sewage disposal
 - (v) Road Works
- (b) **Electrical Engineering Works.**
 - (i) Low Tension Electric Works (upto 1100 Volts).

3. Index No. **D-271** is allotted to you, which shall be quoted by you in all future correspondence. Your previous Index No. **E-143 Mhow (2010)** shall become invalid henceforth. The other details are enclosed as Appendix 'A' & 'B' to this letter.

4. Please note that any change in name/style, address & constitution and change in partners/directors of the firm would require prior approval of the Registering Authority i.e. Chief Engineer Central Command, Lucknow.

5. Please note that you will be required to strictly ensure engagement of engineers and deployment of 'T&P, Machinery & Transport' as stipulated in the respective contracts. Inadequate engagement of engineers/deployment 'T&P, Machinery & Transport' as per contract conditions shall be considered as serious lapse attracting ban/removal/downgrading/debarment of the Firm/Company

6. Please note that you will either obtain valid Electrical License of required class in your name or engage an agency having valid Electrical License of required class through proper agreement/MOU for execution of all electrical works under category (b) & category (c) [including all sub-categories] and category (d) (v) to the extent Rule 29 under Part III of Central Electricity Authority (Measures Relating to Safety and Electric Supply) Regulation, 2010 is applicable, forming either full or part of the scope of work of contracts awarded to you. All such works shall be executed by you through such agency only (either yourself or other agency) having valid Electrical Licence of required class. Such Electrical Licence shall be obtained from the concerned authority of State Government/Union Territory where the works are to be executed. Any violation of this condition shall be sufficient reason for taking such disciplinary action as deemed fit by the Registering Authority apart from other recourse/remedy available to the Department under the conditions of contract for such lapse.

7. Following further points may be noted: -

(a) You will keep this HQ informed about the persons working with you who are near relative(s) of any Gazetted/Commissioned Officer or Junior Engineer in MES/Corps of Engineers/Ministry of Defence. Similarly, you will also intimate the name(s) of the persons(s) who is/are near relatives(s) of the Proprietor/Partners/Directors and working as Junior Engineers(s) and/ or Gazetted/ Commissioned officers(s) in MES/Corps of Engineers/Ministry of Defence.

(b) You will not be entitled for issue of tenders in certain areas (as mentioned below), where such near relative(s) is/are working. Decision of the Registering Authority shall be final in this regard.

Note: 1. The term "near relative" means wife, husband, parents, children, brothers, sisters, uncles, first cousins, brothers/sisters-in-law, sons/daughters-in-law and father/mother-in-law.

2. You shall not be eligible to tender for the works under following conditions:-
(i) The works in **entire area of CE Zone**, where near relative(s) of the Proprietor/Partners/Directors/their employees is/are working as Gazetted/ Commissioned Officers.

(ii) The works in **entire area of CWE/GE(I)**, under whom near relative(s) of the Proprietor/Partners/Directors is/are working as Junior Engineer(s).

(c) Any breach of above condition(s) by you shall render your firm liable to be removed from the approved list of contractors of the department

8. Please note that signatory of correspondence with the Department shall clearly mention name and authority under which he/she is communicating. No cognisance of letters without these details may be taken and you shall be solely responsible for consequence of such correspondence.


9. Please note that the appropriate MES authority has the right as he may decide, not to admit e-tender in any particular case and also to suspend, remove or blacklist your name from the MES approved list of contractors in the event of submission of non-bonafide tenders or for technical or other delinquency, in regard to which the decision of such appropriate MES Authority shall be final and conclusive.

10. Please note that if you fail to secure any work in MES/DG MAP or any Govt Deptt /PSU/AWHO/AFNHB/DGNP/CGEWHO or in any other Government Department within a period of five years from the date of issue of this letter, your firm will be liable for removal from the list of approved contractors.

11. Please note that your enlistment in class 'D' is valid upto **31 Dec 2025** and the application for renewal will be required to be submitted by the date as notified/ conveyed through website during the process of renewal.

12. You are advised to browse the MES website www.mes.gov.in regularly to update yourself about relevant policy instructions issued by the department and rules, regulations of Govt of India issued time to time relating to enlistment/upgradation/change in constitution/renewal and other subjects like contract matters, taxes, levies, labour related issues and all other issues having bearing on tendering and bidding process as well as execution of works, which a bidder/contractor is expected to be aware of. No letter conveying such information & policy instructions shall be issued separately by the department.
