1. Reference this HQ letter of even No. dated 20 Jul 2018 & 05 Sep 2018.
2. The required structural changes have been made in LIMBS Portal, accordingly, please expedite the process of creating user ID and Password at Command and Zone level to log on to the LIMBS Portal. Thereafter, upload the complete data relating to court cases handled by your respective Command immediately and update regularly.
3. The sequence of Registration would be as under:-

(i) Select Ministry	-	Defence
(ii) Department	-	MES E1 Legal (O) MES E1C (Legal) MES E1D (D&V) MES MIS (Civ) MES E VIII (Contracts)
(iii) Sub Department	-	Select concerned Zonal/Command CE
(iv) Functional Department	-	Legal
4. After the structural changes as mentioned in the category of Department five Department are shown, you have to create a user ID & Password for each of the Department separately.

5. Once your office has created a user ID & Password, the following concerned department may be contact to verify the user ID:-

7. There would be many offices who have already created their user Login ID under D/Works-II and there cases are already uploaded on the LIMBS website. For those offices also a fresh user ID has to be created as per direction given in Para-5 above, but they need to again liaise with LIMBS Team and request them if that data could be deleted from that Login ID and shifted to be new user ID created or if not to get that data and user ID deleted to prevent duplicacy.
