However non-submission of physical copies of cost of tender shall be considered as willful negligence of the bidder with ulterior motives and such bidder shall be banned from

bidding for a period of six months commencing from the date of opening of finance bid (cover 2). In case of applications/bids from unenlisted contractors, where scanned copies of requisite DD/Bankers (iv) Cheque towards cost of tender has been uploaded but physical copies are not received by the stipulated date, finance bids will not be opened. Name of such contractors alongwith complete address shall be circulated for not opening of their bids for a period of six months commencing from the date of opening of finance bid (cover 2).

In case of applications/bids (enlisted contractor as well as unenlisted contractor) where scanned copies of (v) requisite Earnest money (as applicable) were uploaded but the same are not received in physical form within stipulated time, such bid shall not qualify for opening of finance bid (cover 2).

Solvency certificate and working capital certificate issued by Schedule Bank. (ii)

Annual turnover certificate for last 2 years issued by Chartered Accountant alongwith relevant pages of (iii) audited balance sheets in support thereof.

Affidavits for possession of movable & immovable proprietor/partner owning the immovable properly (iv) alongwith valuation certificate from Regd valuer in supper movable & immovable properties. In case of Limited company, the immovable property is required to be in the name of the company.

In addition the un-listed contractors shall also furnish affidavit on non judicial stamp paper in the form of (v) hard copy declaring their turn over for last 02 (two) years.

(vi) Scanned copy of DD of cost of tender and earnest money.

In case of rejection of technical/prequalification bid, contractor may appeal to next higher Engineer authority i.e. (h) HQ CWE SGNR on email sgnr3-mes@nic.in against rejection, whose decision shall be final and binding. However contractor/bidder shall not be entitled to any compensation whatsoever for rejection of technical/prequalification bid.
