8	<u>Eligibility Criteria:-</u> (a) For MES enlisted contractors	Class D & above with category a(i) Note: All tenderers enlisted with MES of eligible class as notified in NIT shall be considered qualified for opening of Finance bid (cover II) subject to meeting the following additional eligibility criteria. (i) There should not be any adverse remarks in work load returns circulated by various appropriate authorities in MES, or known from any other sources. (ii) MES Enlisted E-Class contractors can also participate subject to fulfillment of requirement mentioned under para 3.5.5.2 (b) of Manual of Contracts- 2007 (Reprint- 2012)
	(b) For un-enlisted contractors	(a) The tenderers not enlisted with MES shall meet the enlistment criteria of class D & above with category a(i) i.e. with regard to having satisfactorily completed requisite value works, Annual turnover, Solvency, working capital immovable property/fixed assets, T & P, Engineering establishment, no recovery outstanding in any Govt Department, police verification/ pass ports etc. Enlistment criteria may be seen in para 1.4 of section 1 of part I of MES Manual on contracts -2007 (Reprint 2012) as available in all MES formations.
	(c) For all Contractors	Contractor will not be allowed to execute the work by submitting or throw power of attorney holder on his behalf to a third party/ another firm except son/ daughter of proprietor/ partner/ director and firm's own employees, Director, Project Manager. This shall be subject to certain conditions which will be prescribed in the NOT forming part of the tender documents.

1. The Contractors enlisted in one class below the Eligible class given above may also submit bids. The Accepting officer may consider such bids in case of inadequate response from eligible class contractors.
2. Tenders not accompanied by requisite value DD towards cost of Tender and other documents shall be rejected. Demand draft and other documents as notified in NIT shall reach **GE Bengdubi** within **five days** from last date of submission of bid online (excluding the Last date of submission of bid) failing which necessary disciplinary action shall be initiated against the defaulting firms.
3. Contractor enlisted with MES will submit following documents for checking eligibility:-
 - (i) Scanned copy of application for issue of tender on firm's letter pad.
 - (ii) Scanned copy of DD towards cost of tender.
 - (iii) Scanned copy of Enlistment letter.
 - (iv) Scanned copy of Employees provident fund number.
 - (v) Scanned copy of GST registration number.
 (Contractor not in possession of EPF No, GST Regn. No. shall be disqualified in 'T' Bid evaluation and his finance bid shall not be opened.)
4. Contractors not enlisted with MES will be required to enclose necessary documents to prove their eligibility for enlistment in eligible class & category of work, including Affidavit that no recovery is outstanding. List of documents required for enlistment in MES has been given in section 1.5 of section 1 of part I of MES Manual on contracts 2007 (reprint 2012). These contractors shall also submit scanned copy of earnest money and following documents
 - (i) Scanned copy of application for issue of tender on firm's letter pad.
 - (ii) Working details of Bid Capacity.
 - (iii) Scanned copy of DD towards cost of tender.
 - (iv) List of works in hand and remaining work to be completed during completion period of subject work on stamp paper of Rs. 100/- duly notarized.
 - (v) Copy of last Income tax returns/Balance sheet.
 - (vi) Any other document considered necessary by the bidder to demonstrate eligibility.
 - (vii) Scanned copy of Employees provident fund number
 - (viii) Scanned copy of GST registration number
5. Contractors not enlisted with MES will be required to enclose necessary documents to prove their eligibility for enlistment in eligible class & category of work, including Affidavit that no recovery is outstanding. List of documents required for enlistment in MES has been given in section 1.5 of section 1 of part I of MES Manual on contracts 2007 (reprint 2012). These contractors shall also submit scanned copy of earnest money and documents listed in note 4 (i),(ii), iii),(iv), (v),(vi), (vii) & (viii) above.
6. In case of rejection of technical/prequalification bid, contractor may appeal to next higher Engineer authority i.e CWE Bengdubi , whose decision shall be final and binding. However contractor shall not be entitled to any compensation whatsoever for rejection of technical/prequalification bid.
7. During evaluation of T-bid (Cover-1) of E-tendering, uploading of copy of Provident Fund code number and GST registration number in addition to other documents required shall be mandatory. Contractor not in possession of this number shall be disqualified in 'T' bid evaluation and his finance bid shall not be opened.
8. Court of the place from where tender has been issued shall alone have jurisdiction to decide any dispute out of or in respect of this tender. After acceptance of tender, Condition 72 – Jurisdiction of Courts of IAFW-2249 shall be applicable.
