The amount of cost of tender shall be recovered from any amount due to the MES enlisted contractor. Failure of non-submission of hard copy of DD tantamount to willful negligence with ulterior motive and therefore the tenderer shall be barred to tender during the period of 6 months commencing from the date of opening of financial bid (cover 2). It is mandatory for the contractors to upload their GST Registration Number alongwith the 'T' bid. This will be on of the criteria for qualifying in 'T' bid. Contractor, who does not upload GST Registration Number, shall be disqualified in the 'T' bid Evaluation and his Financial bid shall not be opened. (b) In case of MES un-enlisted tenderers, if original DD is not received before opening of cover 1 ('T' bid), the cover 1 shall not be opened. Name of such contractors along with complete address shall be circulated for not opening of bids for the period of six months commencing from the date of opening of financial bid (cover 2). It is mandatory for the contractors to upload their GST Registration Number alongwith the 'T' bid. This will be on of the criteria for qualifying in 'T' bid. Contractor, who does not upload GST Registration Number, shall be disqualified in the 'T' bid Evaluation and his Financial bid shall not be opened.

(i) The applicant contractor shall note that the demand draft/ Banker's Cheque shall be in favor of concern GE, cost of tender documents shall be non-refundable. However DD/Banker's Cheque shall be returned to the applicants whose cover No: 2 is not opened Please note that cover No: 2 (Price bid) will be opened only in respect of qualified and eligible contractor who fulfils the eligibility/ criteria according to their tech bid submitted in cover No. 1 (applications/ technical bid).

(ii) Uploading of bid does not constitute any guarantee for opening of price bid of tenderer. Opening of price bid (cover No. 2) of tender will be decided by the Accepting Officer based on interalia, past track record, financial position & experience of similar works executed by the applicant/ contractor. ## 1. EXPERIENCE

(a) Three works costing not less than Rs. 7.50 Lakh.

(b) Average annual turnover for last two consecutive years shall not less than Rs. 25.00 Lakh and one work costing not less than Rs. 7.50 Lakh.

**NOTE:** List of works executed by the contractor, Copy of work orders, completion certificate, audited balance sheet for last two consecutive years and performance report from the respective department shall be uploaded by the contractor at the time of submission of on-line bid.

## 2. FINANCIAL SOUNDNESS

(a) Solvent upto Rs 10.00 Lakh.

Or

Financially sound for engagement upto Rs 25.00 Lakh.

(b) Working capital not less than Rs 5.00 Lakh.

**NOTE:** Solvency and working capital certificate from a scheduled Bank as per format below shall be uploaded by the contractor at the time of submission of on-line bid.

3. ENGINEERING ESTABLISHMENT

One graduate Engineer from a Government recognized institution.

Or

One diploma Engineer from Government recognized institution with minimum experience of 02 years.

**Note:** Affidavit duly notarized indicating engagement of engineer by the contractor and consent of appointee along with pass certificate of engineer shall be uploaded by the contractor at the time of submission of on-line bid.

4. LIMIT OF MINIMUM RESERVE/ASSETS (IMMOVABLE AND MOVABLE)

**Rs 08.00 Lakh** – 80% of minimum reserve shall be in the form of immovable property.

**Note:** Affidavit duly notarized indicating details of property held by the proprietor/Partners/Ltd Company and copy of valuation report reflecting ownership details carried out by the Govt registered valuer shall be uploaded by the contractor at the time of submission of online bid. The affidavit shall, inter-alia, include the followings:-

(a) That the immovable and movable property is free from mortgage, hypothecation or any other disputes and encumbrances and clearly belongs to the contractor. That the immovable property is free from any & encumbrances and clearly belongs to the contractor.

5. T &P: The firm should give an affidavit duly notarized for the T& P held by them.

6. POLICE VERIFICATION

Copy of police verification certificate (not older than 06 months) of proprietor/Partners/Directors from police authority of the area where registered office is located. Alternatively notarized copy of valid passport of proprietor/partners / each director can be submitted.
