	(a) For MES Enlisted contractors:	Contractors enlisted with MES in Class 'E' and above and category b(i) subject to the remarks wrt performance in respect of wks in hand reflected in Workload Return (WLR) submitted by competent engineer authority.
	(b) For Contractors not enlisted with MES:	The firms not enlisted with MES shall meet the enlistment criteria of 'E' class MES contractors and category b(i) ie, with regard to having satisfactory completed requisite works annual turnover Solvency working capital movable property/fixed assets T&P Engineering Establishment, no recovery outstanding or any Govt department Police verification/Passport etc. Enlistment criteria may be seen in Para 1.4 of section of Part 1 of MES Manual on Contracts – 2007 (reprint 2012) as available in all MES formations. These firms shall also submit copy of Police verification from police authority of the area where the registered office of the firm is located/notarized copy of valid passport of proprietor/each partner/each Director. They should not carry adverse returns in WLR or any other similar report of any authority. Contractor will not be allotted to execute the work by letting or through power of attorney holder on his behalf to third party/another firm except sons/daughters of proprietor/partner/Director and firms own employees, Projectors, Projects Manager. This shall be subject to certain conditions which will be prescribed in the NOT forming part of tender documents.

Notes -

- (a) Contractor one class below (two class) in case of remote and difficult area may also bid for this tender. Their application shall be considered subject to fulfillment of other eligibility criteria given in NIT when number of applicants of eligible class qualifying for the tender are less than 7 (seven).
- (b) In case number of eligible class contractor application of one class below the eligible class and not be considered except those who have previously completed similar works satisfactorily and are meeting the criteria of up gradation in respect of past experience and/ or average annual turnover as applicable and financial soundness (solvency/financial soundness and working capital) provided the value of work less than twice the tendering limit of such contractors. Contractors one class below the eligible class may upload necessary documents wrt work experience and financial soundness in cover 1 of tender (T Bid).
- (c) (i) Applications/bids not accompanied by scanned copies of requisite DD/Bankers Cheque towards cost of tender and earnest money (as applicable) shall not be considered for validation of 'T' bid and their financial bids will not be opened.
- (ii) Tenderers/bidders to note that they should ensure that their original DDs and earnest money (as applicable) are received within 05 days of bid submission end date. (*The number of days to be mentioned shall be as decided by the Accepting Officer but is shall not be less than 5 days)
- (iii) In case of applications/bids from non-enlisted contractors of MES where scanned copied of requisite DD/Bankers Cheque towards cost of tender has been uploaded but physical copies are not received by the tendering authority. However, non submission of physical copies of cost of tender shall be considered as willful negligence on the bidder with ulterior motives and such bidder shall be banned from bidding for a period of six months.

- (iv) In case of applications/bids from unenlisted contractors, where scanned copies of requisite DD/Bankers Cheque towards cost of tender has been uploaded but physical copies are not received by the stipulated date finance bid will not open. Name of such contractor's alongwith complete address shall be circulated for not opening of their bids. period of six months commencing from the date of opening of finance bid (Cover 2).
- (v) In case of applications/bids (eligible contractors as well as unenlisted contractor) where scanned copies of requisite earnest money (as applicable) were uploaded but the same are not received in physical form within stipulated time such bids shall not qualify for opening of finance bid (cover 2).
- (d) Contractors may note that they shall not be allowed beyond their tendering limit as under:-
 - (i) In case contractors of eligible class are selected for issue of tender : 4 to 5 times the tendering limiting.
 - (ii) In case of one class (two class in case of remote and difficult area as the case may be) contractors are selected for issue of tender : 6 to 7 times
 - (iii) In case of unenlisted contractor : 2 times the upper tendering limit of class for which contractor meets the criteria for enlistment.
- (e) In case of any deficiency is noted, in the documents required to be uploaded by the tenderers as per NIT, after opening of cover 1 (T Bid) and due to technical evaluation a communication in the form of e-mail/whatsapp/sms/speed post etc shall be sent to the contractor to rectify the deficiency within a period of 7 days from the date of communication failing which financial bid (cover-2) shall not be opened and contractor shall not have any claim on the same.
- (f) Contractors enlisted with MES will upload following documents for checking eligibility:
 - (a) Application for bid in Firm's letter head
 - (b) Enlistment letter
 - (c) Scanned copy of DD of cost of tender
 - (d) Copy of EPF
 - (e) Copy of GST.
- (g) Contractors not enlisted with MES will be required to upload necessary documents to prove their eligibility for enlistment in eligible class and category of work including Affidavit for no recovery outstanding. List of documents required for enlistment in MES has been given in Para 1.5 of section 1 of Part 1 MES Manual of Contracts 2007(reprint 2012). Following document shall be uploaded amongst others:-
 - (i) Details of three highest values similar nature of works executed during last five years financial year wise in tabular form giving name of work, Accepting Officer, details viz. Address, Telephone, Fax No, E-Mail ID etc. Date of acceptance of tender and actual date of completion. This shall be duly signed by proprietor/all partners/authorized Director of Pvt/Public Ltd, as applicable. It should indicate whether extension was granted or compensation was levied. Attested copy of acceptance letter and completion certification shall be enclosed of each work in case performance report has been given by the client same shall also submitted duly attested.
 - (ii) Solvency certificate and working Capital Certificate issued by scheduled bank.
 - (iii) Annual turnover certificate for last 2 years issued by Chartered Accountant along with relevant pages of audited balance sheets in support thereof.
 - (iv) Affidavit for possession of movable and immovable properties by proprietor /partner owning the immovable property alongwith valuation certificate from Regt valuer in support of movable and immovable properties in case of Limited Company the immovable property is required to be in the name of the company.
 - (v) In addition, the un-enlisted contractors shall also furnish affidavit on non Judicial stamp paper in the form of hard copy declaring their turnover for last 2 (two) years.
 - (vi) Scanned copy of DD of cost of tender and earnest money.
- (h) In case of rejection of technical/prequalification bid, contractor may appear to next higher Engineer Authority i.e HQ CWE Btd on email against rejection, whose decision shall be final and binding. However, contractor/bidder shall not be entitled to any compensation whatsoever for rejection of technical /prequalification bid.
