	(B) For other contractors	(a) The firm not enlisted with MES shall meet the enlistment criteria of ' <b>E</b> ' class MES contractors and category " <b>a(ii) &amp; b(i)</b> " i.e. with regard to having satisfactorily completed requisite value works, Annual turnover, Solvency, working capital, immovable property/ fixed assets, T&P, Engineering establishment, no recovery outstanding in any Govt Department, Police verification/Passport etc. Enlistment criteria may be seen in Para 1.4 of Section 1 of Part-I of MES Manual of Contracts – 2007 (Reprint 2012) as available in all MES formations. (b) These firms shall also submit copy of Police verification from police authority of the area where the registered office of the firm is located/ notarized copy of valid passport of proprietor/ each partner/ each Director. **Notes:**

- (a) The contractor enlisted upto one class below the eligible class may also apply/bid. Applications/ bids from one class below eligible class applicants may be considered in the event of inadequate response/bids from the applicants of eligible class.
- (b) (i) Applications/ bids not accompanied by scanned copies of requisite DD/Bankers Cheque towards cost of tender and earnest money (as applicable) shall not be considered for validation of 'T' bid and their financial bids will not be opened.
- (ii) Tenderers/ bidders to note that they should ensure that their original DDs and earnest money (as applicable) are received within stipulated time limit as indicated under Para 12 (h) here in before.
- (iii) In case of applications/bids from enlisted contractors of MES, where scanned copies of requisite DD/ banker's cheque towards cost of tender has been uploaded by physical copies are not received by the stipulated date, finance bids will be opened. However, non-submission of physical copies of cost of tender shall be considered as willful negligence of the bidder with ulterior motives and such bidder shall be banned from bidding for a period of six months commencing from the dates of opening of finance bid.
- (iv) In case of applications/ bids from unenlisted contractors, where scanned copies of requisite DD/ Bankers Cheque towards cost of tender has been uploaded but physical copies are not received by the stipulated date, finance bids will not be opened. Name of such contractor's alongwith complete address shall be circulated for not opening of their bids for the period of six months commencing from the date of opening of finance bid.
- (v) In case of applications/ bids (enlisted contractor as well as unenlisted contractor) where scanned copies of requisite Earnest money (as applicable) were uploaded but the same not received in physical form with stipulated time, such bids shall not qualify for opening of finance bid.

- (d) Contractors not enlisted with MES will be required to upload necessary documents to prove their eligibility for enlistment in eligible class and category of work (besides documents mentioned under Note No C (i) to (iv) here in before), including Affidavit for no recovery outstanding. List of documents required for enlistment in MES has been given in Para 1.5 of section 1 of Part-I of MES Manual on Contracts 2007 (reprint 2012). Following documents shall also be uploaded amongst others: -
- (i) Details of three highest valued similar nature of works executed during last five years, financial year-wise in tabular form giving name of work, Accepting Officer's details, viz, Address, Telephone, Fax No, E-mail ID etc. date of acceptance of tender and actual date of completion. This shall be duly signed by proprietor/all partners/ authorized Director of pvt/ Public Lts, as applicable. It should indicate whether extension was granted or compensation was levied. Attested copy of acceptance letter and completion certificate shall be enclosed of each work. In case performance report has been given by the client same shall also be submitted duly attested.
  - (ii) Solvency certificate and working Capital Certificate issued by schedule bank.
  - (iii) Annual turnover certificate for last 2 years issued by Chartered Accountant along with relevant pages of audited balance sheets in support thereof.
  - (iv) Affidavits for possession of movable and immovable properties by proprietor/partner owning the immovable property along with Valuation Certificate from RegdValuein support of movable and immovable properties. In case of Limited Company, the immovable property is required to be in the name of the company.

  - (v) In addition, the un-enlisted contractors shall also furnish affidavit on non-judicial stamp paper in the form of hard copy declaring their turnover for last 2 (Two) years.
  - (vi) Scanned copy of earnest money.
- (e) In case of rejection of technical/ prequalification bid, contractor may appeal to next higher Engineer authority i.e. **HQ CWE Ranchi** on e-mail [ranchicwe@yahoo.in](mailto:ranchicwe@yahoo.in) against rejection, whose decision shall be final and binding. However contractor/ bidder shall not be entitled to any compensation whatsoever for rejection of technical/prequalification bid.
