(* This shall be two in case of works in remote and difficult stations and following additional provision to be added: "Application from two class below eligible class applicants may be considered in the event of inadequate response from the applicants of eligible class and one class below eligible class")

- (i) Application s/bids not accompanied by scanned copies of requisite DD/bankers cheque towards (b) cost of tender and earnest money (as applicable) shall not be considered for validation of 'T' bid and their finance bid will not be opened.
 - (ii) Tenders/bidders to note that they should ensure that their original DDs and earnest money (as applicable)

are received within 05 days* of bid submission end date.
