- (b) (i) Application s/bids not accompanied by scanned copies of requisite DD/bankers cheque towards cost of tender and earnest money (as applicable) shall not be considered for validation of 'T' bid and their finance bid will not be opened.
 - (ii) Tenders/bidders to note that they should ensure that their original DDs and earnest money (as applicable)

are received within 05 days* of bid submission end date.

(* The number of days to be mentioned shall be as decided by the Accepting Officers but it shall not be less than 5 days).

Following documents shall also be uploaded amongst others.
 - (i) Details of three highest valued similar nature of works executing during last five years, financial year-wise in tabular form giving name of work, Accepting Officer's details, viz, Address, Telephone, Fax No., e-mail ID etc. date of acceptance of tender and actual date of completion. This shall be dually signed by the proprietor / All partners / authorized Director of Pvt./ public Ltd, as applicable. It should indicate whether extension was granted or compensation was levied. Attested copies of acceptance letter and completion certificate shall be enclosed of each work. In case performance report has been given by the client same shall also be submitted duly attested.
 - (ii) Solvency certificate and working capital certificate issued by scheduled bank.
 - (iii) Annual turnover certificate for last two years issued by charted accountant alongwith relevant pages of audited balance sheets in support thereof.
- (iv)Affidavits of possessions of movable and immovable properties by proprietor / partner owning the immovable property alongwith valuation certificate from Regdvaluer in support of movable or immovable properties. In case of limited company, the immovable property is required to be in the name of the company.
