- (b) (i) Application s/bids not accompanied by scanned copies of requisite DD/bankers cheque towards cost of tender and earnest money (as applicable) shall not be considered for validation of 'T' bid and their finance bid will not be opened.
  - (ii) Tenders/bidders to note that they should ensure that their original DDs and earnest money (as applicable)

are received within 05 days\* of bid submission end date.

- (\* The number of days to be mentioned shall be as decided by the Accepting Officers but it shall not be less than 5 days).

Attested copies of acceptance letter and completion certificate shall be enclosed of each work. In case performance report has been given by the client same shall also be submitted duly attested.
- (ii) Solvency certificate and working capital certificate issued by scheduled bank.
