Contractor, who does not upload Goods and Service Tax Registration No. shall be disqualified in the 'T' bid evaluation and his Financial bid shall not be opened.
 - (v) All the tenderers/bidders shall note that uploading of copy of provident fund Code No. in addition to the other documents as stated above in technical bid (cover-1) is mandatory. The bidders who will not upload Provident fund Code No. his bid shall be disqualified and his financial bid shall not be opened.
- (d) Contractors not enlisted with MES will be required to upload necessary documents to prove their eligibility for enlistment in eligible class & category of work, including Affidavit for no recovery outstanding. - (ii) Solvency certificate and working Capital Certificate issued by scheduled bank.
- (iii) Annual turnover certificate for last 2 years issued by Chartered Accountant along with relevant pages of audited balance sheets in support thereof.
- (iv) Affidavits for possession of movable & immovable properties by proprietor/partner owing the immovable property along with valuation certificate from registered valuer in support of movable & immovable properties.
