**Cost of tender fee/documents:-**

**Rs.500 /-** (Rupees five hundred only) by way of Demand Draft from any Nationalised Bank in favour of **GE (AFA) Hyderabad** payable at **Hyderabad**. In case of MES enlisted tenders, if original DD is not received within period stated above, subject to satisfying other prequalifying criteria, the financial bid shall be opened. The amount of cost of tender shall be recovered from any amount due to the MES enlisted contractor. Failure of non submission of hard copy of DD tantamount to willful negligence with ulterior motive and therefore the tenderer shall be barred to tender during the period of 6 months commencing from the date of opening of financial bid. PF No of principal employers to be uploaded otherwise the bid will be rejected/suspended under General conditions of contracts forming part of contracts.

**Note1:-** The DD shall be non-refundable if the Accepting Officer decides to open BoQ The Contractor shall bear the cost of Bank Charges for procuring and encashing the Bank Draft. The Bidder shall not become automatically entitled to allow for quoting BOQ or opening their bids by virtue of forwarding demand draft and the Accepting Officer shall reserve the right to deny opening of BOQ in respect of any bidder. However, the DD shall be returned to the bidder by the Accepting officer in the event of not opening the BOQ. The contractor shall not have any claim whatsoever on this account on Govt.

**Note 2 :** Opening of quoted BOQ will be decided based on satisfaction of pre-qualification and documentation criteria given in NIT. The Bidder will be informed regarding non-opening of their bids with reasons. The Bidder if he desires, may appeal to the next higher Engineer Authority via CWE (AF) Secunderabad with copy to the Accepting Officer. The decision of the next higher Engineer Authority shall be final and binding. Bidder shall not be entitled for any compensation whatsoever for rejection of his BOQ. In order to participate in e-tendering, Bidders have to enroll in **[www.eprocure.mes.gov.in](http://www.eprocure.mes.gov.in)**. Enrollment for the bidders is free and they can participate in all tenders after the enrollment. The facilities provided for the Bidders in the site may be utilized for quoting and uploading etc. Digital application received without scanned copy of demand draft shall not be considered for issue of tender. The DD shall be non-refundable if the application for issue of tender forms is accepted and tender documents in blank are issued to the contractor after scrutiny and selection. The contractor shall bear the cost of Bank Charges for procuring and encashing the Bank Draft. The applicant shall also renew or forward fresh DD at his own cost on demand by Accepting Officer in case of delay in issue of tender failing which the applicant's request for issue of tender shall be rejected and he shall not have any claim whatsoever on this account on Govt. The applicant contractor shall not become automatically entitled for issue of tender by virtue of enclosing demand draft along with the application and the Accepting Officer shall reserve the right to deny issue of tender to any applicant contractor without assigning any reasons. The contractor shall not have any claim whatsoever on this account on Govt.

**NOTE 3:-** Court of the place from where tender has been issued shall alone have jurisdiction to decide any dispute out of or in respect of this tender. After acceptance of tender **Condition No 72** – Jurisdiction of Courts of IAFW -2249 shall be applicable.

**Note4:**            **THE ELIGIBILITY CRITERIA FOR ENLISTED/UN-ENLISTED CONTRACTORS**

1.     **MES Enlisted Contractor** (documents to be uploaded):
- (a)     An application form requesting issue of tender.
  - (b)     Enlistment letters along with its enclosures.
  - (c)     Scanned copy of Demand Draft towards the cost of tender to be uploaded.
  - (d)     Scanned Copy of **GST** Registration Number and Provident Fund Code Number for qualifying in Technical Bid.
  - (e)     Mere uploading of the above documents will not guarantee for opening of financial bid. The financial bid will be opened after verification of past record and latest workload remarks of the Contractor/firm. No claim whatsoever of firm on this account will be admissible. Union of India reserves the right to reject such tenders.

- 2**     **Un-Enlisted Contractor** (documents to be uploaded):  
Contractors not enlisted with MES will be required to upload the following necessary documents to prove their eligibility for :-
- (i)     Meeting enlistment criteria of MES with regard to having satisfactorily completed requisite value of works, annual turnover, working capital, fixed assets verification of character and antecedents of proprietor/partner/directors etc and affidavit for no recovery outstanding (Enlistment criteria are available in all MES offices and MES website).
  - (ii)    Tenderers shall upload copy of police verification certificate (with in last one yr) from police authorities of the area where the registered office is located. For proprietor/each partner/each director, valid passport duly notarized shall also be applicable in lieu of police verification.
  - (iii)   Scanned copy of Demand Draft towards the cost of blank tender and EMD to be uploaded.
