It is mandatory for the contractors to upload their EPF and GST registration Number alongwith the 'T' bid. Contractor, who does not upload Service Tax regn No and GST registration No shall be disqualified in the 'T' bid evaluation and his finance bid shall not be opened.
	(B) For other contracts		(a) The firms not enlisted with MES shall meet the enlistment criteria of "E" Class MES contractors & <b>Cat a (i)</b> i.e with regard to having satisfactorily completed requisite value works, Annual turnover, solvency, working capital, immovable property/fixed assets, T&P, Engineering establishment, no recovery outstanding in any Govt Department, Police verification/passport etc. Enlistment criteria may be seen in Para 1.4 of section 1 of Part I of MES Manual on Contracts 2007 (Reprint 2012) as available in all MES formations. Name of such Contractors along with complete address shall be circulated for not opening of their bids for a period of six months commencing from the date of opening of finance bids.

The shall be duly signed by proprietor/all partners/authorized Director of Pvt/Public Ltd, as applicable. It should indicate whether extension was granted or compensation was levied. Attested copy of acceptance letter and completion certificate shall be enclosed of each work. In case performance report has been given by the client same shall be submitted duly attested.
	(ii)		Solvency certificate and working Capital Certificate issued by scheduled bank.
	(iii)		Annual turnover certificate for last two years issued by Chartered Accountant alongwith relevant pages of audited balance sheets in support thereof.

	(iv) Affidavits for possession of movable & immovable properties by proprietor/partner owning the immovable property along with Valuation Certificate from Regd Valuer in support of movable & immovable properties in case of limited Company, the immovable property is required to be in the name of the company. In case off limited company, the immovable property is required to be in the name of the company.
	(v) In addition the un-enlisted contractors shall also furnish affidavit on non Judicial Stamp paper in the form of hard copy declaring their turnover for last 2 (two) years.
	(vi) Scanned copy of DD of cost tender and earnest money
(e)	In case of rejection of technical/prequalification bid, contractor may appeal to next higher Engineer authority i.e HQ 137 Works Engineer on email : <b>cwedisapur@gmail.com</b> against rejection, whose decision shall be final and binding. However contractor/bidders shall not be enlisted to any compensation whatsoever for rejection of technical/prequalification bid.
