If his near relative(s) is/are working in such capacity, the contractor shall furnish details. The contractor shall not be entitled to tender for the works in entire area of GE in which his near relative(s) is/are working as Junior Engineer.

(xi) **Police verification** :- Copy of police verification certificate from police authority of the area where registered office is located. Alternatively notarised copy of valid passport of proprietor/each partner/each director can be submitted.

(xii) **Certificate regarding no recovery outstanding in any Govt department**:- Affidavit to the effect that no recovery of any kind is outstanding in any Government department to be furnished.

(xiii) **Certificate regarding no Arbitration/Litigation cases** :- Affidavit to the effect that no Arbitration/litigation cases is outstanding in any Government department to be furnished.

(F) The Demand draft shall be non-refundable, if the participation for online e-tender is accepted after scrutiny. However it shall be returned back by accepting officers in case the application is rejected. The applicants shall bear the cost of Bank charges for procuring and encashing the Demand draft and they shall not have any claim whatsoever on this account on Government. Please also note that the contractor / applicant shall not become automatically entitled for participation in tender process by virtue of enclosing demand draft along with application and the accepting Officer shall reserve his right to deny participation in e-tender any applicant without assigning any reason.

(G) In case, in the opinion of accepting officer, inadequate Nos of bid are received from eligible applicant/ contractors on the closing date and tie of online bid submission, then accepting officer at his discretion may extend the closing date and time of online bid submission for number of times as he may consider appropriate. (H) Admissibility to participate in tender will be decided by the Accepting Officer based on interlia, past track record, financial position and experience of similar works executed by the applicant / contractor. In the event of rejection of application. Participation in tender, the applicant /contractor will be communicated via system generated SMS/ E- mail. The applicant / contractor can also access his user account on [www.defeprocuremes.gov.in](http://www.defeprocuremes.gov.in) to find out admission / rejection of his bid. The applicant / contractor, if he so desires may appeal to the next higher Engineer Authority i.e Commander Works Engineer Mathura with a copy to the accepting officer. No appeal/ presentation shall be entertained after due date of receipt of financial bid. The decision of the next higher Engineer authority shall be final and binding. No application / contractor shall be entitled for any compensation whatsoever for rejection of his application.

(J) The accepting officer reserve the right to accept a tender submitted by a public undertaking giving a price preference over other tender, Which may be lower as are admissible under Government. Policy. No claim for any compensation or otherwise shall be admissible to such tender whose tender may be rejected on account of the said policy
