

**MILITARY ENGINEER SERVICES**  
**NOTICE OF TENDER**

- 1.1 A tender is invited for the work as mentioned in Appendix 'A' to this notice of Tender.
- 1.2 The work is estimated to cost as indicated in aforesaid Appendix 'A'.
- 1.3 This estimate, however, is not a guarantee and is merely given as a rough guide and if the work costs more or less, a tenderer will have no claim on that account even if the variation in cost is too much.
- 1.4 The type of tender shall be as mentioned in aforesaid Appendix 'A'.
2. The work is to be completed within a period as indicated in aforesaid Appendix 'A' in accordance with the phasing, if any, indicated in the tender from the date of handing over of the site, which may be on or about two weeks after the date of acceptance of the tender.
  - 3.1 Normally contractors whose names are borne on the MES approved list for the area in which the work lies and within whose financial category the estimated amount would fall may tender, in case where the tendered amount is in excess of the financial category, whether or not the estimated amount was within the financial category of the contractor, the Accepting Officer reserves the right to accept the tender, in which event the tenderer would be required to lodge "Additional Security Deposit" as notified by the Accepting Officer, in terms of conditions of contracts.
  - 3.2 Contractors whose names are borne on the MES approved list of any MES formation and who have deposited standing Security and have executed Standing Security Bond, may also tender without depositing Earnest Money alongwith the tender and if the Accepting Officer proposes to accept the tender, such tenderer would be required to deposit "Security Deposit" as notified by the Accepting Officer before acceptance of tender. In case, however, the Accepting Officer subsequent to deposition of Security Deposit decides not to accept the tender for any reason whatsoever, the amount deposited will be refunded to the tenderer. Not more than one tender shall be submitted by one contractor or one firm of contractors.
  - 3.3 Under no circumstances will a father and his son(s) or other close relations who have business dealing with one another, will be allowed to tender for the same contract as separate competitors. Breach of this condition will render the tenders of both parties liable for rejection.
4. The Commander Works Engineers (Hills), Dehradun will be the Accepting Officer hereinafter referred to as such for the purpose of this contract.
  - 5.1 Applications for the tender forms must be submitted to the Commander Works Engineers (Hills), Dehradun so as to reach this office on or before as mentioned in aforesaid Appendix 'A'.
  - 5.2 Invitation of application for issue of tender does not constitute any guarantee for issue of tender to applicant even to enlisted contractors of appropriate Class. Issue of tender will be decided based on past track records, financial position, experience of similar works and decision for issue of tender or otherwise of the Accepting Officer shall be final and contractor will not be entitled for any compensation for rejection of his application. The Accepting Officer does not bind himself to intimate the reasons for rejection of such an application.
6. Tender forms and conditions of contract and other necessary documents (together with addressed envelopes to be used for the return of tender forms and documents) will be issued on and after as mentioned in aforesaid Appendix 'A'.
  - 7.1 The appropriate standing security amount for this work shall be as deposited by contractor enlisted in the area in which the work lies for category mentioned in aforesaid Appendix 'A'.
  - 7.2 In case of contractor who has not executed the "STANDING SECURITY BOND". The tender shall be accompanied by "Earnest Money" for the amount referred to in the aforesaid Appendix 'A' in the form of deposit at call receipt in favour of AGE (I) mentioned in aforesaid Appendix 'A' by Scheduled Bank/or receipted treasury challan, the amount being credited to the revenue deposit of the AGE (I). A contractor who is not enlisted for the area in which the work lies, but whose name is in the MES approved list of any MES formation and who has deposited Standing Security and executed Standing security bond, may tender without depositing earnest money alongwith the tender, but if the Accepting Officer decides to accept tender, such tenderer shall lodge security deposit as notified by Accepting Officer with the "ACCEPTING OFFICER", in prescribed form before acceptance of tender.

**NOTICE OF TENDER (CONTD...)**

- 7.3 A contractor who has executed the standing security bond but not for the appropriate category as mentioned above, shall lodge with the Controller of Defence Accounts concerned additional security deposit as notified by the Accepting Officer within thirty days of receipt by him of notification of acceptance of the tender, failing which, this sum will be recovered from RAR payment or from the first final bill in case of term/running contract. However, in case where any payment is made to the contractor within thirty days of receipt by him of notification of acceptance of tender, the amount of additional security deposit shall be recovered from such payment.
- 7.4 GE will return the Earnest Money wherever applicable to all unsuccessful tenderers, by endorsing an authority on the deposit receipt for its refund, on production by the tenderer of a certificate of the Accepting Officer, that a bonafide tender (vide condition 13 below) was received and all documents were returned.
- 7.5 The AGE (I) will either return the Earnest Money to the successful tenderer, by endorsing an authority on the deposit receipt for its refund, on receipt of an equal amount of security deposit or will retain the same on account of security deposit, if such transaction is feasible.
- 8.1 Copies of the drawings and other documents pertaining to the work (signed for the purpose of identification by the Accepting Officer or his accredited representative) and samples of materials and stores to be supplied by the contractor will be open for inspection by the tenderers in the offices of CWE/GE as mentioned in the aforesaid Appendix 'A' during office working hours.
- 8.2 The tenderers are advised to visit site by making prior appointment with the AGE (I) by giving sufficient time.
- 8.3 A tenderer shall be deemed to have full knowledge of all relevant documents, samples, site etc. whether he has inspected them or not.
9. Tenders will be received by the Commander Works Engineers (Hills), Dehradun on the date and time indicated in the aforesaid Appendix 'A'.
10. Any tender which proposes any alteration to any of the conditions laid down or proposes any other conditions of any description whatsoever, is liable to be rejected, except in case of specialist type of works where the contractor is asked to give his own design/drawing and technical data.
11. The submission of tender by a tenderer implies that he has read this notice and the conditions of contract and had made himself aware of the scope and specification of the work to be done and of the conditions and rates at which stores, tools and plants etc will be issued to him and local conditions and other factors bearing on the execution of the work.
12. Tenderers must be in possession of copy of MES Standard Schedule of Rates Part I-2009 & Part II-2010 including errata/ amendments thereto.
13. Tenderers must be very careful to deliver a bonafide tender or in the alternative, return BLANK TENDER complete with all the documents forming part of the tender. Accepting Officer, may at his absolute discretion, reserves the right to take action against such firm who fails either to submit the tender or return blank tender. A bonafide tender must satisfy each and every condition laid down in this Notice.
14. Accepting Officer does not bind himself to accept the lowest or any tender or to give any reason for not doing so.
15. This notice of tender shall form part of the contract.

8.	Eligibility criteria	
	(A) For MES enlisted contractors	All contractors enlisted with MES in Class 'E' & above and category 'a(i)' shall be considered qualified provided they do not carry adverse remarks in WLR of competent Engineer Authority.
	(B) For Other contractors	(a) The firm not enlisted with MES shall meet the enlistment criteria of 'E' class MES contractors and category 'a(i)' i.e. with regard to having satisfactorily completed requisite value works, Annual turnover, solvency, working capital, immoveable property/fixed assets, T&P, Engineering establishment, no recovery outstanding in any Govt Department, Police verification/passport etc. Enlistment criteria may be seen in Para 1.4 of Section 1 of Part I of MES Manual on Contracts – 2007 (Reprint – 2012) as available in all MES formations. (b) These firms shall also submit copy of police verification from police verification from police authority of the area where the registered office of the firm is located/ notarised copy of valid passport of proprietor/each partner/each Director. (c) They should not carry adverse remarks in WLR/or any other similar report of any authority. (d) They should possess GSTIN.
	(C) For all contractors	Contractor will not be allowed to execute the work by subletting or through power of attorney holder on his behalf to a third party/another firm except sons/daughters of proprietor/partners/Directors and firm's own employees, Director, Project Manager. This shall be subject to certain conditions which will be prescribed in the NIT forming part of the tender documents.

**APPENDIX 'A' TO NOTICE INVITING TENDER (NIT) Contd.....**

- (a) The Contractor enlisted upto one class below the eligible class may also apply/bid. Application/bids from one class below eligible class applicants may be considered in the event of inadequate response/bids from the applicants of eligible class.
- (b) (i) Applications/bids not accompanied by scanned copies of requisite DD/Bankers Cheque towards cost of tender and earnest money (as applicable) shall not be considered for validation of 'T' bid and their finance bids will not be opened.
- (ii) Tenderers/bidders to note that they should ensure that their original DDs and earnest money (as applicable) are received within 07 days of bid submission end date.
- (iii) In case of applications/bids from enlisted contractors of MES, where scanned copies of requisite DD/Bankers Cheque towards cost of tender has been uploaded but physical copies are not received by the stipulated date, finance bids will be opened. However non-submission of physical copies of cost of tender shall be considered as willful negligence of the bidder with ulterior motives and such bidder shall be banned from bidding for a period of six months commencing from the date of opening of finance bid.
- (iv) In case of applications/bids from un-enlisted contractors, where scanned copies of requisite DD/Bankers Cheque towards cost of tender has been uploaded but physical copies are not received by the stipulated date, finance bids will not be opened. Name of such contractors alongwith complete address shall be circulated for not opening of their bids for a period of six months commencing from the date of opening of finance bid.
- (v) In case of applications/bids (Enlisted contractor as well as un-enlisted contractor) where scanned copies of requisite Earnest Money (as applicable) were uploaded but the same are not received in physical form within stipulated time, such bids shall not qualify for opening of finance bid.
- (c) Contractors enlisted with MES will upload following documents for checking eligibility:-
- (i) Application for bid in Firm's letter head.
- (ii) Enlistment letter.
- (iii) Scanned copy of DD of cost of tender.
- (iv) Document pertaining to firm's GST registration number.
- (d) Contractors not enlisted with MES will be required to upload necessary documents to prove their eligibility for enlistment in eligible class & category of work, including Affidavit for no recovery outstanding. List of documents required for enlistment in MES has been given in para 1.5 of section 1 of part I of MES Manual on Contracts 2007 (Reprint 2012). Following documents shall also be uploaded amongst others.
- (i) Details of three highest valued similar nature of works executed during last five years financial year-wise in tabular form giving name of work, Accepting Officer's details viz. Address, Telephone, FAX No, E-mail ID etc, date of acceptance of partners/authorized Director of pvt/Public Ltd. as applicable. It should indicate whether extension was granted or compensation was levied. Attested copy of acceptance letter and completion certificate shall be enclosed of each work. In case performance report has been given by the client same shall also be submitted duly attested.
- (ii) Solvency certificate and working Capital Certificate issued by scheduled bank.
- (iii) Annual turnover certificate for last 2 years issued by Chartered Accountant along with relevant pages of audited balance sheets in support thereof.
- (iv) Affidavits for possession of movable & immovable properties by proprietor/partner owning the immovable property alongwith Valuation Certificate from Regd. Valuer in support of movable & immovable properties. In case of Limited Company, the immovable property is required to be in the name of the company.
- (v) Document pertaining to firm's GST registration number.

**APPENDIX 'A' TO NOTICE INVITING TENDER (NIT) Contd.....**

(v) In addition the un-enlisted contractors shall also furnish affidavit on non Judicial stamp paper in the form of hard copy declaring their turnover for last 2 (Two) years.

(vi) Scanned copy of DD of cost of tender and earnest money.

(e) In case of rejection of technical/prequalification bid, contractor may appeal to next higher Engineer authority i.e HQ Chief Engineer Bareilly Zone Bareilly on email [id\\_cez2-mes@nic.in](mailto:id_cez2-mes@nic.in) against rejection, whose decision shall be final and binding. However, contractor/bidder shall not be entitled to any compensation whatsoever for rejection of technical/prequalification bid.

(f) Court of the place from where tender has been issued shall alone have jurisdiction to decide any dispute out of or not in respect of this tender. After acceptance of tender, Condition 72- Jurisdiction of Courts of IAFW-2249 shall be applicable.
