Invitation for applications for issue of tender does not constitute any guarantee for issue of tender to applicant even to enlisted contractors of appropriate class by virtue of submitting demand draft for issue of tender documents. Issue of tender will be decided by the Accepting Officer based on interalia past work records, financial position and experience of similar works executed by the applicant/contractors. The Accepting Officer shall consider applications received in envelope-01 (T-bid) up to the last date of receipt of the application/ extended date of receipt of applications for issue of tender. Accepting Officer reserves this right to deny issue of tender documents to any applicant. The applicant/contractor will be informed regarding non-issue of tender through e-tendering portal. The applicant/contractor if he so desires, may appeal to the next higher Engineer authority with copy to the Accepting Officer. The decision of the next higher Engineer Authority shall be final and binding. No appeal/representation shall be entertained in respect of applications for issue of tender, received after the due date of receipt of applications/extended date of applications.		

14A	(i) The tenderer is supposed to check if any revised BOQ has been uploaded and quote in revised BOQ only. Thus uploading quotation in pre-revised BOQ shall be considered as a willful negligence by the bidder and his quotation shall be considered as non-bonafide.
	(ii) In case of MES enlisted tenders, if original DD is not received within period of five days, subject to satisfying other prequalifying criteria, the financial bid shall be opened. The amount of cost of tender shall be recovered from any amount due to the MES enlisted contractor. Failure of non submission of hard copy of DD tantamount to willful negligence with ulterior motive and therefore the tenderer shall be banned to tender during the period of 6 months commencing from the date of opening of financial bid.
	(iii) In case of un-enlisted tenderer, if original DD is not received within five days of opening of 'T' bid, the cover 1 ('T' bid) shall not be validated for opening of financial bid. Name of such contractor alongwith complete address shall be circulated for not opening of bids for the period of six months commencing from date of opening of financial bid.
	(iv) Tenderers who have failed to submit original FDR pertaining to Earnest Money deposit (Whether un-enlisted or enlisted who has not lodged Standing Security Deposit) by stipulated date, shall be ineligible for opening of financial bid.
	(iv) Tenderers who have failed to submit original FDR pertaining to Earnest Money deposit (Whether un-enlisted or enlisted who has not lodged Standing Security Deposit) by stipulated date, shall be ineligible for opening of financial bid.
15	Para 17. The Accepting Officer reserves his right to accept a tender submitted by a public sector undertaking, giving a purchase preference over other tender (s) which may be lower, as are admissible under the Government policy. No claim for any compensation or otherwise shall be admissible from such tenderer whose tenders may be rejected on account of the said policy.
16	The tender is online tendering system and applicant must register for online tendering and posses "Digital Signature Certificate".
17	It is mandatory for the tenderer to upload a copy of PROVIDENT FUND CODE NUMBER INTIMATION LETTER in addition to other documents. The tenderer, who has not uploaded a copy of the same, shall be disqualified in 'Tech' bid evaluation and his financial bid shall not be opened".
18	The tenderer/applicants are prohibited for subletting/execution of work through power of attorney.
19	<i>It shall be mandatory for tenderer to upload copy of GST Registration number, otherwise bid of the firm shall be rejected in T-bid evaluation and his/her financial bid shall not be opened</i>

NOTES.

- (i) Application not accompanied by requisite value DD/Bankers Cheque towards Cost of Tender shall not be considered for issue of tender.
- (ii) Enlisted contractor of MES below eligible class shall submit list of similar of work executed for last 7 years and Audited copy of financial turnover for last two years alongwith application. Issue of tender to below eligible class firm shall only be considered if sufficient applications from eligible class contractors are not received. In case of receipt of insufficient bids from the contractors of eligible class, the bids submitted by the contractors one class below eligible class may also be considered. Further in case of receipt of insufficient bids from the contractors upto one class below eligible class, the bids submitted by contractors two class below eligible class may also be considered. There should not be any adverse remarks in work load returns circulated by various appropriate authorities in MES, or known from any other sources.

- (iii) (a) The firms not enlisted with MES shall meet the requisite enlistment criteria to the corresponding class and category as mentioned in SI No. 08. Enlistment criteria may be seen in Para 1.4 of section 1 of part I of MES Manual on Contracts - 2007 (Reprint 2012) as available in all MES formations.
- (b) These firms shall also submit the requisite documents required for the eligible class and category at the time of applying for issued of tender.
- (c) These firms shall also submit copy of Police verification from police authority of the area where the registered office of the firm is located / notarized copy of valid passport of proprietor/each partner/each Director.
- (iv) In case of rejection of application for issue of tender, the applicant shall be refunded the cost of tender. However contractor may appeal to next higher Engineer Authority i.e. HQ CWE (AF) Jodhpur on e-mail afjodh3-mes@nic.in for rejection of his application for issue of tender whose decision shall be final and binding and contractor shall not be entitled to any compensation what so ever for non issue of tender.
- (v) Tenderer shall note that the work shall be got executed by the Proprietor / Partner / Director of the Firm and power of attorney to any other person shall not be accepted.
