7. The tender fees/EMD should receive in the office of the Garrison Engineer (AF) Tech Area M'Pur under sealed cover at least 24 hours before the opening of Cover-1 (Technical Bid), failing which his Cover-1 (Technical Bid) will not be opened.
8. Any deficiency in documentation and non receipt of tender fee, EMD and documents mentioned above in physical form by **28 Dec 2018**, such Bidder's BoQ will not be considered for opening.
9. The bidder, at the bidder's own responsibility and risk is encouraged to visit and examine the site of works and its surroundings and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice of Tender as the work lies in Restricted Area, the cost of visiting shall be at the bidder's own expense. Traffic management and execution shall be the responsibility of the Agency at his /her/their risk and cost.
10. The intending bidders shall clearly understand that whatever may be the outcome of the present invitation of bids, no cost of bidding shall be reimbursable by the Department. Garrison Engineer (AF) Tech Area Maharajpur reserve the right to accept/reject any/all bid documents/offer without assigning any reason whatsoever, and is not liable for any cost that might have incurred any bidder at the stage of bidding.
11. Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in instructions to bidders before bidding.

Bidder not enlisted with MES will require to enclose necessary documents to prove their eligibility for enlistment in eligible class and category for work, including Affidavit that no recovery is outstanding. The bidder shall also submit scanned copy of earnest money and other documents listed in here in before.
13. In case of rejection of technical/prequalification bid, bidder may appeal to next higher Engineer authority i.e HQ CWE (AF) M'Pur, Gwalior whose decision shall be final and binding. However, bidder shall not be entitled to any compensation whatsoever for rejection of technical/prequalification bid.
