### **Notes**

(1) The contractor enlisted upto one\* class below the eligible class may also apply/bid. Application /bids from one class below eligible class applicants may be considered in the event of inadequate response/bids from the applicants of eligible class.

- (2) (i) Applications / bids not accompanied by scanned copies of requisite DD/Bankers Cheque towards cost of tender and earnest money (as applicable) shall not be considered for validation of 'T' bid and their finance bids will not be opened.
  - (ii) Tenderers/bidders to note that they should ensure that their original DD's and earnest money (as applicable) are received within 07(Seven) days of bid submission end date.
  - (iii) In case of applications/bids from enlisted contractors of MEs, where scanned copies of requisite DD/Bankers Cheque towards cost of tender has been uploaded but physical copies are not received by the stipulated date, finance bids will be opened. However, non-submission of physical copies of cost of tender shall be considered as willful negligence of the Bidder with ulterior motives and such bidder shall be banned from bidding for a period of six months commencing from the date of opening of finance bid.
  - (iv)In case of applications/bids from unenlisted contractors, where scanned copies of requisite DD/Bankers Cheque towards cost of tender has been uploaded but physical copies are not received by the stipulated date, finance bids will not be opened. Name of such contractors alongwith complete address shall be circulated for not opening of their bids for a period of six months commencing from the date of opening of finance bid.
  - (v) In case of applications/bids (enlisted contractor as well as un enlisted contractor) where scanned copies of requisite Earnest money (as applicable) were uploaded but the same are not received in physical form within stipulated time, such bids shall not qualify for opening of finance bid.
- (3) Contractors enlisted with MES will upload following documents for checking eligibility:

  - (ii) Enlistment letter
  - (iii) Scanned copy of DD of cost of tender
- (4) Contractors not enlisted with MES will be required to upload necessary documents to prove their eligibility for enlistment in eligible class & category of work, including Affidavit for no recovery outstanding. Following documents shall also be uploaded amongst others.
  - (i) Details of three highest valued similar nature of works executed during last five years financial yearwise in tabular form giving name of work, Accepting Officer's details, viz, Address, Telephone, Fax No, Email ID etc, date of acceptance of tender and actual date of completion. This shall be duly signed by proprietor / all partners / authorised Dirctor of Pvt/Public Ltd, as applicable. It should indicate whether extension was granted or compensation was levied. Attested copy of acceptance letter and completion certificate shall be enclosed of each work. In case performance report has been given by the client same shall also be submitted duly attested.
  - (ii) Solvency certificate (upto Rs. 10.00 Lakhs) and working Capital (not less than Rs. 5.00 Lakhs) Certificate issued by scheduled bank.
  - (iii) Annual turnover certificate for last 2 years issued by Chartered Accountant along with relevant pages of audited balance sheets in support thereof.
