Note:- (a) (i) The applications / bids not accompanied by the scanned copies of requisite DD / Banker's cheque towards cost of tender and earnest money (as applicable) shall not be considered for validation of 'T' bid and their finance bids will not be opened.

(ii) The tenderers / bidders to note that they should ensure that their original DDs and earnest money (as applicable) are received **within six days of bid submission end date**.

(iii) In case of applications / bids from enlisted contractors of MES, where scanned copies of requisite DD / Bankers cheque toward cost of tender has been uploaded but physical copies are not received by the stipulated date, **financial bids will not be opened**. However non-submission of physical copies of cost of tender shall be considered as willful negligence of the bidder with ulterior motives and such **bidder shall be banned from bidding for a period of six months commencing from the date of opening of financial bid**.

(iv) In case of applications / bids from **unenlisted contractors**, here scanned copies of requisite DD / Bankers cheque towards cost of tender has been uploaded but physical copies are not received by the stipulated date, **financial bids will not be opened**. Name of such contractors alongwith complete address shall be circulated for **not opening of their bids for a period of six months commencing from the date of opening of finance bid**.

(v) **Please ensure that at the time of uploading a copy of provident fund code number in addition to other documents required shall be mandatory, if the contractor not in possession of this number shall be disqualified in 'T' bid evaluation and his financial bid shall not be opened.**

(vi) **The applicability of GST on all contracts, it is mandatory for the contractors to upload their GST registration number alongwith the 'T' bid. This will be one of the criteria for qualifying in 'T' bid. Contractor, who does not upload GST regn No shall be disqualified in the 'T' bid evaluation and his financial bid shall not be opened.**

(b) The contractors enlisted with MES will upload following documents for checking eligibility :-

(i) Application for bid in Firm's letter head

(ii) Enlistment letter

(iii) Scanned copy of DD of cost of tender

(vi) Scanned copy of Provident Code Number (v) GST No.

(c) The contractors not enlisted with MES will be required to upload necessary documents to prove their eligibility for enlistment in eligible class & category of work, including Affidavit for no recovery outstanding. List of documents required for enlistment in MES has been given in para 1.5 of section 1 of part I of MES Manual on Contracts 2007 (reprint 2012). Following documents shall also be uploaded amongst others :-

(i) Details of three highest valued similar nature of works executed during last five years, financial year-wise in tabular form giving name of work, Accepting officer's details, viz, Adress, Telephone, Fax No., E-mail ID etc, date of acceptance of tender and actual date of completion. This shall be duly signed by proprietor / all partners / authorized Director of Pvt / Public Ltd, as applicable. It should indicate whether extension was granted or compensation was levied. Attested copy of acceptance letter and completion certificate shall be enclosed of each work. In case performance report has been given by the client same shall also be submitted duly attested.

(ii) Solvency certificate and working capital certificate issued by Scheduled bank.

(iii) Annual turnover certificate for last two years issued by Chartered Accountant along with relevant pages of audited balance sheets in support thereof.

(iv) Affidavit for possession of movable & immovable properties by proprietor / partner owning the immovable property along with Valuation certificate from Regd Valuer in support of movable & immovable properties. In case of Limited Company, the immovable property is required to be in the name of the company.

(v) In addition, the un-enlisted contractors shall also furnish affidavit on non judicial stamp paper in the form of hard copy declaring their turnover for last two years.

(vi) Scanned copy of DD of cost of tender and earnest money.

(d) In case of rejection of technical / prequalification bid, contractor may appeal to next higher Engineer authority i.e. HQ CWE (H) DDN " against rejection, whose decision shall be final and binding. However contractor / bidder shall not be entitled to any compensation whatsoever for rejection of technical / prequalification bid.

2. **Particulars of contractors:** Documents regarding proprietorship/Partnership / Private Limited concern to be submitted. Also, affidavit regarding no sister concern in MES and no near relative in MES.

3. **Financial Soundness (Certificate from bankers on requisite specimen to be furnished).**

- (a) Solvent upto Rs 10.00 Lakh Or Financially sound for engagement upto Rs 25.00 Lakh
 (b) Working capital not less than Rs 5.00 Lakh

4. **Engineering Establishment:-**

- (i) Degree Holders - 01 No from a government recognized institution.
 (ii) Diploma Holders from Govt recog institute – 01 No having experience of 2 years.

Affidavit from the firm as well as from the engineers alongwith copy of their qualification and experience to be furnished.
