- (b) (i) Applications / bids not accompanied by scanned copies of requisite DD/ Bankers Cheque towards cost of tender and earnest money (as applicable) shall be not be considered for validation of 'T' bid and their finance bids will not be opened.
 - (ii) Tenderers/ bidders to note that they should ensure that they should ensure that their original DDs and earnest money (as applicable) are received within 5* days of bid submission end date.
