### (B) For other contractors:

- (a) The firm not enlisted with MES shall meet the enlistment criteria of **E class MES contractors and category d (v)** i.e. with regard to having satisfactorily completed requisite value works, Annual turnover, Solvency, working capital immovable property/fixed assets, T & P, Engineering establishment, no recovery outstanding in any Govt Department, police verification/ pass ports etc. Enlistment criteria may be seen in para 1.4 of section 1 of part I of MES Manual on contracts -2007 (Reprint 2012) as available in all MES formations.
- (b) They should not carry adverse remarks in work load returns/or any other similar report of any authority.
- (c) These contractors shall also submit copy of police verification from police authority of the area where the registered office of the firm is located/ notarized copy of valid passport of proprietor/each partner/each director.

### (C) <u>For All Contractors</u>:

- (i) Contractor will not be allowed to execute the work by subletting or through power of attorney holder on his behalf to a third party/another firm except sons/daughters of proprietor/partner/Director and firm's own employees, Director, Project Manager. This shall be subject to certain conditions which will be prescribed in NOT forming part of tender documents.

- 2. (a) Bids not accompanied by scanned copies of requisite DD/Bankers Cheque towards cost of Tender and earnest money (as applicable) shall not be considered for validation of 'T' bid and their financial bids will not be opened.
- (b) Tenderers / bidders to note that they should ensure that their original DD/Bankers Cheque towards cost of Tender and earnest money (as applicable) are received within <u>07 (Seven) working days of bid submission end date.</u>

- (iv) Affidavits for possession of movable and immovable properties by proprietors/partner owning the immovable property along with Valuation Certificate from Regd valuer in support of movable and immovable properties.
