The contractor enlisted upto one\* class below the eligible class may also apply/bid. Application / bids from one class below eligible class applicants may be considered in the event of Inadequate response / bids from the applicants of eligible class.

(\* This shall be 'two' in case of works in remote and difficult stations and following additional provision to be added: "Application from two class below eligible class applicants may also be considered in the event of inadequate response from the applicants of eligible class and one class below eligible class.")

- (b) (i) Applications/bids not accompanied by scanned copies of requisite DD /Bankers Cheque towards cost of tender and earnest money (as applicable) shall not be considered for validation of 'T' bid and their finance bids will not be opened.
- (ii) Tenderers / bidders to note that they should ensure that their original DDs and earnest money (as applicable) are received within 05\* days of bid submission end date.

- (iii) In case Of applications / bids from enlisted contractors of MES, where scanned copies of requisite DD / Bankers Cheque towards cost of tender has been uploaded but physical copies are not received by the stipulated date, finance bids will be open However non-submission of physical copies of cost of tender shall be considered as willful negligence of the bidder with ulterior motives and such bidder shall be banned from bidding for a period of six months commencing from the date of opening of finance bid.
- (iv) In case of applications / bids from unenlisted contractors, where scanned copies of required DD / Bankers Cheque towards cost of tender has been uploaded but physical copies are not received by the stipulated date, finance bids will not be opened. Name of such contractors alongwith complete address shall be circulated for not opening of their bids for a period of six months commencing from the date of opening of finance bid.
- (v) In case of applications / bids (enlisted contractor as well as unenlisted contractor) where scanned copies of requisite Earnest money (as applicable) were uploaded but the same are not received in physical form within stipulated time, such bids shall not qualify for opening of finance bid.
- (c) Contractors enlisted with MES will upload following documents for checking eligibility:-

- (iv) Affidavits for possession of movable & immovable properties by proprietor / partner owning the immovable property along with Valuation Certificate from Regd Valuer in support of movable & immovable properties In case of Limited Company, the immovable property is required to be in the name of the company.
