- (i). The applicant contractor shall note that the demand draft/banker's cheque shall be in favour of GE(W) Pathankot. Cost of tender documents shall be non-refundable. However, DD/Bankers cheque shall be returned to the applicants whose Cover 2 is not opened. Please note that Cover 2 (financial bid) will be opened only in respect of qualified and eligible contractors/bidders who fulfils the eligibility criteria according to their bids submitted in Cover 1.
- (ii). Uploading of bid does not constitute any guarantee for opening of financial bid of tenderers. Opening of financial bid (Cover 2) of tender will be decided by the Accepting Officer based on interalia, past track record, financial position and experience of similar work executed by the applicant/contractor. The Accepting Officer shall receive applications (Cover 1 and Cover 2) upto the last date and time of bid submission/extended date of bid submission as applicable and as mentioned here-in-before.
