In case after opening of Cover-I, the number of MES enlisted contractors of eligible class as well as eligible un-enlisted contractors, if any, fulfilling the other eligibility criteria given in NIT is less than 7 (Seven), applications in respect of MES contractors of one class below the eligible class shall also be considered subject to fulfillment of other eligibility criteria given in the NIT. 6. Tenders not accompanied by scanned copies of requisite DD/Bankers Cheque towards cost of tender and Earnest money (as applicable) in Cover-1 shall not be considered for validation of Technical bid and their finance bids will not be opened.

7. Contractors should ensure that their original physical DDs and Earnest Money Deposit (EMD) instruments (as applicable) reach the office of Accepting Officer within **07 days** of bid submission end date, failing which following action shall be taken.

(a) In case of tenders from an enlisted contractors of MES, where scanned copies of requisite DD/Bankers Cheque towards cost of tender have been uploaded in Technical bid (Cover 1) but physical copies are not received by the stipulated period, their Financial bid (Cover-2) will be opened.

9.
