NOTE :-

1. The applicants are required to send by speed post the demand draft for EMD and / or cost of tender in the form specified from any Nationalised/Scheduled Bank in favour of GE(AF) Bagdogra payable at Siliguri along with application for consideration of their bid so as to reach in the office of accepting officer one day before the closing date of bid submission.
