 - (d) If above named AO-II is involved in disciplinary case(s) necessary particulars to be given mentioning whether charge sheet has been issued or not. In case the officer has been awarded penalty during last 10 years, the nature of penalty alongwith the relevant particulars & exact date of commencement and expiry of penalty period shall be furnished.
- 3. It is also submitted that MIS (Civ) section of this HQ has intimated that data of APAR / PPAR (index card) in r/o Smt Harsh Lata Chopra, AO-II is not traceable with them. However, as per our record, the officer has assumed the charge of AO-II post wef 21 Sep 2021, hence, thereafter the APAR / PPAR of the officer were required to be initiated through SPARROW portal.
