- 3. The work is to be completed within the period as indicated in aforesaid Appendix 'A' in accordance with the phasing, if any, indicated in the tender from the date of handing over site, which will be on or about two weeks after the date of Acceptance of tender.
- Normally contractors whose names are on the MES approved list for the area in which the work 4. lies, and within whose financial category the estimated amount would fall, may tender/bid but in case of term contracts, contractors in categories 'SS' to 'E' may tender/bid. In the case of term/running contracts, remaining sum shall be recovered from subsequent bill(s) of the contractor.
