- (b) (i) Application s/bids not accompanied by scanned copies of requisite DD/bankers cheque towards cost of tender and earnest money (as applicable) shall not be considered for validation of 'T' bid and their finance bid will not be opened.
 - (ii) Tenders/bidders to note that they should ensure that their original DDs and earnest money (as applicable) are received within 05 days* of bid submission end date.
 - (* The number of days to be mentioned shall be as decided by the Accepting Officers but it shall not be less than 5 days).
 - (iii) In case of Application/bid from enlisted contractors of MES, where scanned copies of requisite DD/Bankers cheque towards cost of tender has been uploaded but physical copies are not received by stipulated date, finance bids will be opened. Name of such contractors alongwith complete address shall be circulated for not opening of their bids for a period of six months commencing from the date of opening of finance bid.
 - (v) In case of application/bids (enlisted contractors as well as unenlisted contractors) where scanned copies of requisite Earnest Money (as applicable) were uploaded but the same are not received in physical form within stipulated time, such bids shall not qualify for opening of finance bid.

- (ii) Solvency certificate and working capital certificate issued by scheduled bank.
- (iii) Annual turnover certificate for last two years issued by charted accountant alongwith relevant pages of audited balance sheets in support thereof.
- Affidavits of possessions of movable and immovable properties by proprietor / partner (iv) owning the immovable property alongwith valuation certificate from Regd value in support of movable or immovable properties. In case of limited company, the immovable property is required to be in the name of the company.
- In addition, the un-enlisted contractors shall also furnish affidavit on non Judicial stamp paper in the form of hard copy declaring their turnover for last 2 (Two) years.
