- (i) The applicant contractor shall note that the demand draft/Banker's cheque shall be in favour of GE (Maint) Ezhimala. However DD/Banker's cheque shall be returned to the applicants whose Cover-2 is not opened. Please note that Cover-2(price bid) will be opened only in respect of qualified and eligible contractor who fulfils the eligible/criteria according to their Tech bid submitted in Cover-1(applications/technical bid).
- (ii) Invitation for tender does not constitute any guarantee for opening of bid of the applicant, even to enlisted contractor of appropriate class and category.
- (iii) Opening of tender will be decided by the Accepting Officer based on interalia, Past track record, financial position and experience of similar works executed by the applicant/contractor. The Accepting Officer shall consider applications received up to the date of receipt of bid opening /extended date of receipt of bid opening. The applicant/contractor will be informed regarding non- opening of Cover-2(Price bid). The applicant/contractor, if he so desires, may appeal to the next higher engineer authority with copy to the Accepting Officer.
- (iv) The decision of next higher engineer authority shall be final. No applicant/contractor shall be entitled for any compensation whatsoever, for rejection of his application/non opening of Cover-2(Price bid).
