- (* This shall be two in case of works in remote and difficult stations and following additional provision to be added: "Application from two class below eligible class applicants may be considered in the event of inadequate response from the applicants of eligible class and one class below eligible class")
- (b) (i) Application s/bids not accompanied by scanned copies of requisite DD/bankers cheque towards cost of tender and earnest money (as applicable) shall not be considered for validation of 'T' bid and their finance bid will not be opened.
 - (ii) Tenders/bidders to note that they should ensure that their original DDs and earnest money (as applicable) are received within 05 days* of bid submission end date.
 - (* The number of days to be mentioned shall be as decided by the Accepting Officers but it shall not be less than 5 days).
 - (iii) In case of Application/bid from enlisted contractors of MES, where scanned copies of requisite DD/Bankers cheque towards cost of tender has been uploaded but physical copies are not received by stipulated date, finance bids will be opened. However non-submission of physical copies of cost of tender shall be considered as willful negligence of the bidder with ulterior motives and such bidder shall be banned from bidding for a period of six months commencing from, the date of opening of finance bid.
 - (iv) In case of application/bids from unenlisted contractors, where scanned copies of requisite DD/Bankers Cheque towards cost of tender has been uploaded but physical copies are not received by the stipulated date, finance bid will not be opened. Name of such contractors alongwith complete address shall be circulated for not opening of their bids for a period of six months commencing from the date of opening of finance bid.
 - (v) In case of application/bids (enlisted contractors as well as unenlisted contractors) where scanned copies of requisite Earnest Money (as applicable) were uploaded but the same are not received in physical form within stipulated time, such bids shall not qualify for opening of finance bid.

- (iv) Affidavits of possessions of movable and immovable properties by proprietor / partner owning the immovable property alongwith valuation certificate from Regd value in support of movable or immovable properties.
