4. Please note that any change in name/style and constitution of the Company and change in Directors would require prior approval of Registering Authority. Please also intimate any change in your permanent address.



6. Please ensure submission of your audited balance sheet and profit & loss statement regularly as per the Memorandum and Articles of Association of your Company.

7. Please also note that signatory of correspondence with the Deptt shall clearly mention name and authority under which he/she is communicating. No cognisance of letters without these details may be taken and you shall be solely responsible for consequences of such correspondence.

Please note that you will not be entitled to tender for the works under following conditions: -
- (i) The works in entire area of CE Zone/Project under whose control your/your employees' near relative is working as Gazetted/Commissioned Officer.
- (ii) The works in entire area of CWE/GE (I), under whom your near relative is working as Junior Engineer.
- Note:** - The term "near relative" means wife, husband, parents, children, brothers, sisters, uncle, first cousin, brothers/sisters-in-law, sons/daughters-in-law and father/mother-in-law.
- (b) Any breach of above condition by you shall render your Company liable to be removed from the approved list of contractors of the department.

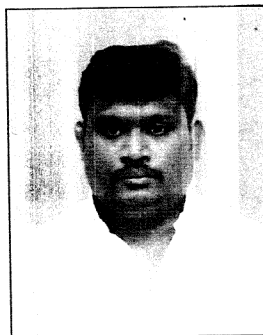

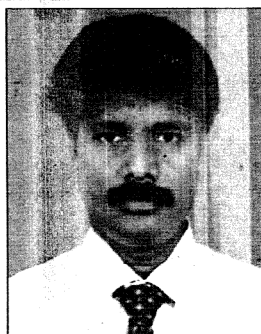
