NOTES

1. In case after opening of Cover- 1, the number of MES enlisted contractors of eligible class as well as eligible un-enlisted contractors,if any, fulfilling the other eligibility criteria given in NIT is less than 7 (Seven),applications in respect of MES contractors of one class below the eligible class shall also be considered subject to fulfillment of other eligibility criteria given in the NIT. Therefore MES contractor's one class below may also bid for this tender. Such contractors (contractors of one class below the eligible class) shall not be considered in case their present residual work in hand is more than FIVE TIMES their present tendering limit. However in case such contractors fulfill the criteria of upgradation to the stipulated eligible class based on past experience of completed works (individual work experience and /or average annual turnover,as applicable) and financial soundness (solvency/financial soundness and working capital),the ceiling of present residual work will not apply and they will be considered for issue of tender. Such bidders shall upload in their Cover-1 bid details related to residual work in hand showing names of work names of Accepting Officers, Contract amounts, dates of commencement and completion (stipulated) and progress as on bid submission date.Such contractors,if claim to fulfill the criteria of upgradation shall also upload the requisite information/documents in support of upgradation. These details shall be verified by the Tender Issuing Authority from concerned formations in case bids of such contractors are considered for evaluation.
2. In case after opening of Cover- 1, the number of MES enlisted contractors of eligible class as well as un-enlisted contractors, if any, fulfilling the other eligibility criteria given in NIT, are 7 (Seven) or more, applications of only those one class below the eligible class bidders shall be considered, who have previously completed similar works satisfactorily and are meeting the criteria of upgradation in respect of past experience of completed works (individual work experience and/or average annual turnover as applicable) and financial soundness (solvency/financial soundness and working capital) as per details given in Manual on contracts. Therefore such contractors shall upload the requisite information/documents in the Cover-1.
3. Unenlisted contractor shall be considered provided he meets the criteria. Foreign firms shall not be eligible for this tender. However Indian Firms having foreign national/Indian nationals staying abroad/Indian national having taken foreign citizenship, as director (s) shall be considered subject to security clearance from the concerned authorities.
4. Contractors enlisted with MES will upload following documents in Cover-1 for checking eligibility:-
 - (a) Application for tender on Firm's letterhead.
 - (b) Enlistment letter issued by the Registering Authority duly renewed for the cycle period in vogue.
 - (c) Scanned copy of DD /Bankers Cheque toward cost of tender and Earnest Money Deposit (EMD) instrument in case SSD bond is not signed at the time of registration.
 - (d) GST Registration Number
 - (e) Integrity Pact duly signed on each page by the bidder shall be uploaded as a part of Technical bid (Cover-1).
 - (f) MOU with precast concrete manufacturing meeting the criteria as laid down in Appendix 'A'
5. Contractors not enlisted with MES will be required to upload following documents in Cover -1 for checking eligibility:-
 - (a) Application for tender on Firm's letterhead.
 - (b) Scanned copy of DD /Bankers Cheque toward cost of tender and Earnest Money Deposit (EMD) instrument.
 - (c) Copy of Police Verification Report/Police Clearance Certificate/ Character Certificate from the Police Authority of the area where the registered office of the firm is located/notarized copy of valid passport of Proprietor/each Partner/each Director.
 - (d) All documents required for enlistment in MES for the class mentioned in Para 8 (b) above as per Para 1.5 of Section 1 of MES Manual on Contracts 2020.
 - (e) Details of works being executed in MES, if any.
 - (f) GST Registration Number
 - (g) Integrity Pact duly signed on each page by the bidder shall be uploaded as a part of Technical bid (Cover-1).

6. Tenders not accompanied by scanned copies of requisite DD/Bankers Cheque towards cost of tender and earnest money (as applicable) in Cover-1 shall not be considered for validation of 'T' bid and their Financial Bids will not be opened.
7. Contractors should ensure that their original physical DDs and Earnest Money Deposit (EMD) instruments (as applicable) reach the office of Accepting Officer within 7 days of bid submission end date, failing which following action shall be taken.
- (a) In case of tenders from an enlisted contractor of MES, where scanned copies of requisite DD/ Bankers Cheque towards cost of tender have been uploaded in Cover- 1 but physical copies are not received within the stipulated period, their financial bids (Cover 2) will be opened. However non submission of physical copies of cost of tender shall be considered as willful negligence of the tenderer with ulterior motives and such tenderer shall be banned from bidding for a period of six months commencing from the date of opening of Financial Bid (Cover-2).
- (b) In case of tenders from unenlisted contractor, where scanned copies of requisite DD/Bankers Cheque towards cost of tender have been uploaded in Cover- 1 but physical copies are not received within the stipulated period, their financial bids (Cover- 2) will not be opened. Name of such contractors along with complete address shall be circulated for not opening of their bids for a period of six months commencing from the date of opening of Financial bid(Cover - 2).
- (c) In case of tenders from enlisted and unenlisted contractors, where scanned copies of instruments for Earnest Money Deposit (as applicable) have been uploaded in Cover- 1 but the same are not received in physical form within stipulated period, such tenders shall not qualify for opening of Financial bid (Cover- 2).
8. Contractor will not be allowed to execute the work by subletting or through power of attorney to a third party/another firm on his behalf. However a contractor can execute the work through power of attorney to sons/daughters/spouse of Proprietor/Partner/Director and firm's own employees, director, project manager **provided they are not having a separate enlisted firm in MES in their name as Proprietor/Partner/Director.**
9. After opening of Cover- 1 and during its technical evaluation, in case any deficiency is noticed in the documents required to be uploaded by the tenderers as per NIT, a communication in the form of E-mail/SMS /Speed Post etc shall be sent to the contractor to rectify the deficiency within a period of seven days from date of communication failing which their Financial Bid (Cover- 2) shall not be opened and contractor shall not have any claim on the same.
10. Invitation for e-tender does not constitute any guarantee for validation of Technical bid and subsequent opening of Financial bid of any applicant/bidder merely by virtue of enclosing DD. Accepting Officer reserves the right to reject the Technical Bid and not to open the Financial Bid of any applicant/bidder. Technical Bid validation shall be decided by the Accepting Officer based on eligibility of the firm as per criteria given in this Appendix. Tenderer/Bidder will be informed regarding non-validation of his Technical Bid assigning reasons therefore through tender evaluation report which shall be uploaded on the website. Such tenderer, if desires, may appeal to the next higher Engineer Authority (NHEA) viz HQ CE WC Chandimandir on email id ceengrcl-mes@nic.in with copy to the Accepting Officer on Email before the scheduled date of opening of Cover- 2. NHEA shall decide the matter within a period of seven working days from the date of receipt of appeal. The decision of the NHEA shall be final and binding. The tenderer/bidder shall not be entitled for any compensation whatsoever for rejection of his bid.
11. In case an unenlisted contractor is already executing works in MES, he shall not be considered eligible for the subject tender if the total value of such works is more than twice the tendering limit of the MES class of contractor for which it is eligible. For the purpose, details of the works being executed by such a contractor shall be uploaded in the cover- 1 of the bid and shall be checked/verified by the Accepting Officer.
12. In case the BOQ is revised through the corrigendum and the bidder has failed to quote on revised BOQ (i.e he has quoted on pre revised BOQ), such bid shall be treated as willful negligence by the bidder and his quotation shall be considered non bonafide. In such cases the lowest tender shall be determined from amongst the valid/bonafide bids only. Accepting Officer may decide whether to re-tender or consider the lowest bonafide tender for acceptance.
13. **Hard copy of the documents as mentioned above will be submitted within 5 (Five) days of the last date & time of opening of „T“ bid (Cover 1).**
14. **MOU** The bidder should either have required experience of working with Pre-cast concrete technology for construction of buildings (Residential, Commercial), or should enter into MOU with Pre Cast element manufacturer, if the bidder himself does not have the required facilities given in Appendix 'A". The details of the above mentioned Pre Cast element manufacturer and related documents qualifying the criteria of Precast concrete Technology work shall be submitted by the Bidders.. In case, main bidder himself has the required facilities of Precast concrete technology, he shall have to submit such documents in respect of facilities during Tender Stage. In case bidder or Pre cast element manufacturer wants to setup/relocate a yard for manufacturing precast concrete elements as per tender documents ,he can do so but outside the defence land at his own cost and under his own arrangement. Relocated facility should have complete setup/details qualifying the criteria of Precast concrete Technology work. In case of non performance of pre cast concrete manufacturing firm with whom MOU has been entered by the contractor, the contractor may either enter into fresh MOU with any other precast concrete manufacturing meeting the criteria as laid down in Appendix 'A' with prior approval of Accepting officer.

16. Important Instructions:

- 16.1 Contractor shall upload copy of Goods and Service Tax (GST) registration certificate of their company. In case of failure to upload and submit the document, the firm shall be disqualified in technical bid evaluation.
- 16.2 Before issue of the Work Order after acceptance of tender, Contractor shall ensure that they have Provident Fund Code number, if applicable, and shall also ensure compliance of EPF & MP Act, 1952.
- 16.3 In the technical bid, a scanned copy of Power of Attorney in favour of the person uploading the bid using his/her DSC shall be uploaded. In case the digital signatory himself is the sole proprietor, scanned copy of affidavit on stamp paper of appropriate value to this effect stating that he has authority to bind the firm in all matters pertaining to contract including the Arbitration Clause, shall be attached in „pdf“ form. In case of partnership concern or a limited company, digital signatory of the bid/tender shall ensure that he is competent to bind the contractor (through partnership deed, general power of attorney or Memorandum and Articles of Association of the Company) in all the matters pertaining to the contracts with Union of India including arbitration clause. A scanned copy of the documents confirming of such authority shall be attached with the tender/bid in „pdf“ form, if not submitted earlier. The person uploading the bid on behalf of another partner(s) or on behalf of a firm or company using his DSC shall upload with the tender/bid a scanned copy (in „pdf“ form) of Power of Attorney duly executed in his favour by such other or all of the Partner(s) or in accordance with constitution of the company in case of company, stating that he has authority to bind such other person of the firm or the company, as the case may be, in all matters pertaining to the contract including Arbitration Clause.
- 16.4 Even in case of Firms or Companies which have already given Power of Attorney to an individual authorizing him to sign tender in pursuance of which bids are being uploaded by such person as a routine, fresh Power of Attorney duly executed in his favour stating specifically that the said person has authority to bind such partners of the Firm, or the Company as the case may be, including the condition relating to Arbitration Clause, should be uploaded in „pdf“ form along with the tender/bid; unless such authority has already been given to him by the Firm or the Company. It shall be ensured that power of attorney shall be executed in accordance with the constitution of the company as laid down in its Memorandum & Articles of Association.
17. **Performance Security** : Please refer condition 19 of General Conditions of Contract (IAFW-2249) (as amended under amendment No 47 thereto).

18 EXPERTISE OF EPC MODE OF WORKING (REQUISITE TECHNICAL MANPOWER)

- (i) If the contractor have the requisite in-house expertise for Architectural, Structural and other Engineering Design for B/R and E/M Services then the contractor shall provide details of technical manpower held on their strength. The minimum strength of technical manpower for design and Engineering (Not for execution, which shall be as per General Conditions of Contracts) portion of the work shall be as under:-

- (ii) If however the Contractor does not have the requisite in-house expertise, they shall submit details of MoU with a consultancy firm which has requisite experience of undertaking consultancy of similar nature of projects with amounts not less the estimated cost of the subject work. The consultancy firm is also required to have minimum strength as technical manpower as given in table of note 18 (i) above.

- 19 **PERFORMANCE & OTHER REQUIREMENT** :Bidder shall fulfil the following requirement
- (a) There should not be poor/slow progress in running work. (If yes, submit details and reasons of delay to check that these are not attributable to him or are beyond his control).
 - (b) There are no serious defect observed in works which stand un-rectified (If yes, submit details and reasons)
 - (c) There are no cancelled/ abandoned contracts in which Govt unrealized recoveries exist (If yes, submit details and reasons)
 - (d) He/They have not been blacklisted by any Govt Deptt (If yes, submit details and reasons)
 - (e) There is no Government dues outstanding against the firm (If yes, submit details and reasons)
 - (f) Proprietor/partners/directors of firm are not involved in anti national/anti social activities and have neither been convicted nor any proceeding are pending in court for such activities
 - (h) Firm should have been considered capable of taking more load in work load return circulated by MES. In case the firm is not considered capable for taking more work load due to unsatisfactory performance in the running works, in the prevailing report circulated by MES their technical bid shall be rejected.
- 20 **DISQUALIFICATION**: Even though the tenderers meet the above criteria, they are liable to be disqualified if they have made misleading of false information in bidding documents submitted.
21. **INTEGRITY PACT (IP)** :IP duly signed by Accepting Officer/Authorized Officer has been uploaded along with this tender as **Annexure –II**. The same shall be signed by bidder(s) on each page and scanned copy shall be uploaded as part of Technical bid (cover-1) and original IP duly signed on each page shall be forwarded by post alongwith tender fee and EMD (if applicable) . IP will be an integral part of the Contract and both parties are bound by its provision.
22. **Q-BID EVALUATION** :
- a. Arithmetical corrections shall be made as per General Condition of Contracts 6A(A) of IAFW 2249.
 - b. Commercial Bids will be reviewed to ensure that the figures indicated therein are consistent with the details of the corresponding Technical bids.
 - c. For the purpose of evaluation "cost" shall be inclusive of all taxes and duties.
 - d Bidder who has quoted lowest total cost in Schedule „A" (L-1) shall be considered successful bidder and all other bidders shall be considered unsuccessful. Offer of successful bidder (L-1) shall only be considered for acceptance. If L-1 backs out, retendering shall be resorted in a fair and transparent manner.
 - e Completion Period as indicated in Tender Document have been accepted.
23. If bidders/ tenderers desire that any condition or stipulation given in the tender documents is to be modified/amended or deleted, they may submit their comments/suggestions before last working date of clarification as shown in critical date sheet in subject tender ID alongwith supporting documents, as applicable, for consideration by the Deptt for issue of corrigendum/amendments to tender documents. If deptt considers comments/ suggestions to be appropriate, corrigendum/amendments to tender documents shall be issued and also uploaded on E-tendering Portal. If department does not consider comments/suggestion suitable, corrigendum/amendments to tender documents shall not be issued/uploaded on E- tendering Portal and tenderers shall quote strictly complying with the various provisions given in the tender documents.
- 24 **PROPRIETARY DATA**
All documents and other information supplied by the Employer or submitted by a Bidder to the Authority shall remain or become the property of the Authority. Bidders are to treat all information as strictly confidential and shall not use it for any purpose other than for preparation and submission of their Bid. The Authority will not return any Bid or any information provided along therewith.
- 25 **COST OF BIDDING**
The Bidders shall be responsible for all of the costs associated with the preparation of their Bids and their participation in the Bidding Process. The Employer will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of the Bidding Process.

26 SITE VISIT AND VERIFICATION OF INFORMATION

- 26.1 Bidders are encouraged to submit their respective bids after visiting the Project site and ascertaining for themselves the site conditions, soil condition, location, surroundings, climate, availability of power, water & other utilities for construction, access to site, handling and storage of materials, weather data, applicable laws and regulations, and any other matter considered relevant by them by carrying out necessary survey/investigation. Bidders are advised to visit the site and familiarise themselves with the Project within the stipulated time of submission of the Bid. No extension of time is likely to be considered for submission of Bids.
- 26.2 It shall be deemed that by submitting a Bid, the Bidder has:
- (a) made a complete and careful examination of the Bidding Documents, Schedules annexed to EPC agreement Document;
 - (b) received all relevant information requested from the Employer; accepted the risk of inadequacy, error or mistake in the information provided in the Bidding Documents or furnished by or on behalf of the Authority relating to any of the matters referred to in Clause 26.1 hereinabove. No claim shall be admissible at any stage on this account.
 - (c) satisfied itself about all matters, things and information including matters referred to in Clause 26.1 here-in-above necessary and required for submitting an informed BID, execution of the Project in accordance with the Bidding Documents and performance of all of its obligations there under;
 - (d) acknowledged and agreed that inadequacy, lack of completeness or incorrectness of information provided in the Bidding Documents or ignorance of any of the matters referred to in Clause 26.1 hereinabove shall not be a basis for any claim for compensation, damages, extension of time for performance of its obligations, loss of profits etc. from the Authority, or a ground for termination of the Agreement by the Contractor;
 - (e) acknowledged that it does not have a Conflict of Interest; and
 - (f) agreed to be bound by the undertakings provided by it under and in terms hereof.
- 26.3 The Employer shall not be liable for any omission, mistake or error in respect of any of the above or on account of any matter or thing arising out of or concerning or relating to RFP, including any error or mistake therein or in any information or data given by the Authority.
27. The contractor may utilize the services of consultants for preparation of architectural details and structural details and preparation of architectural and structural drawings through reputed qualified and experienced consultants in this field. The name of such consultants shall be got approved by the contractor from the Accepting Officer. The consultants proposed by contractor for this purpose shall meet the eligibility criteria for enlistment of consultants corresponding to the applicable Group based on the estimated cost of the work/project as stipulated in the Standard Operating Procedure laid down in Engineering-in-Chief Branch letter No 93348/MISC/Consul/51/E-2 Des-1 dated 06 Mar 2013. While proposing the name of such consultants for approval, the contractor shall enclose the relevant documents in support of the eligibility criteria as mentioned in above letter. The consultant shall be engaged for the work through a proper MOU till completion of project.
28. The contractor shall employ qualified and experienced agents for getting the works of various services executed wherever there is requirement for this purpose as approved by the Accepting Officer or the authorized Engineer Authority on its behalf.
29. In case of rejection of technical /prequalification bid, bidder may appeal to Next Higher Engineer Authority i.e Chief Engineer Western Command on email id ceengrcl-mes@nic.in with copy to the Accepting Officer on Email before the scheduled date of opening of Cover- 2. NHEA shall decide the matter within a period of seven working days from the date of receipt of appeal. The decision of the NHEA shall be final and binding. The tenderer/bidder shall not be entitled for any compensation whatsoever for rejection of his bid.
30. In case the BOQ is revised through the corrigendum and the bidder has failed to quote on revised BOQ (i.e he has quoted on pre revised BOQ), such bid shall be treated as willful negligence by the bidder and his quotation shall be considered non bonafide. In such cases the lowest tender shall be determined from amongst the valid/bonafide bids only. Accepting Officer may decide whether to re-tender or consider the lowest bonafide tender for acceptance.
31. Revoking the offer or revising the rates upward or offering voluntary reduction by the lowest tenderer after opening of Cover-2 shall be considered as a willful default. For this default a penalty of an amount equal to Earnest money shall be levied. In case of an unenlisted tenderer, Earnest Money deposited by him shall be forfeited. In case of MES enlisted tenderer having deposited the Standing Security Bond, an amount equal to the earnest money stipulated in the NIT, shall be notified to the tenderer for depositing through MRO and consideration of such tenderer in tender evaluation for future works shall remain suspended till the aforementioned amount is deposited in the Government Treasury. No other disciplinary/administrative action shall be taken against such tenderers. In such a situation, the next lowest offer shall not be considered for acceptance. Instead, retendering shall be resorted to in a transparent and fair manner and the defaulting tenderer and his related firm if any, shall not be eligible for this tender in second call or subsequent calls.

32. Court having original jurisdiction over the place from where tender has been issued shall alone have jurisdiction to decide over any dispute out of or in respect of issue related to bidding under this tender. After acceptance of tender, Condition 72 (Jurisdiction of Courts) of General Conditions of Contract (IAFW-2249) shall be applicable.
